2017 Department of Interior Tribal Consultation Annual Report

The annual report is a summary of BOEM consultations during one fiscal year. The information in the Annual Report is a summary and was compiled from all of the information captured during the FY 2017 fiscal year.

I. Summarize and list all of the consultation topics.

BOEM reaches out to federally recognized tribes that have a connection to a proposed BOEM action. BOEM conducts consultation with those tribes through a variety of approaches, depending on the scope, scale and significance of an undertaking. This could include face-to-face, government-to-government meetings for complex, controversial, or large scale actions; other approaches include letters sent by certified mail, followed up with phone calls and emails. BOEM tribal liaisons also answer questions and requests for information from tribal staff as requested on a case by case basis.

Atlantic:

BOEM lead outreach to federally recognized tribes along the Atlantic Coast in the proposed program areas for these actions.

- Geological & Geophysical Surveys on the Outer Continental Shelf of the Atlantic
- 2019-2024 Outer Continental Shelf (OCS) Oil and Gas Leasing Program
- Block Island Transmission System (Narragansett Indian Tribe)

Atlantic Renewable Energy Programs:

Richard Warner, Cultural Resources Specialist, was appointed Tribal Liaison Representative for the Office of Renewable Energy Programs (OREP).

BOEM conducted five government to government tribal consultation meetings in May and June 2017 related to offshore Renewable Energy Development. The goal of these meetings was to provide tribal governments with an overview of offshore wind energy projects in the waters off southern New England and Long Island. These discussions emphasized upcoming proposals from Deepwater Wind New England, Bay State Wind, and Vineyard Wind in the Rhode Island and Massachusetts Wind Energy Areas, and from Statoil for the New York lease area. In addition, the meetings included discussions concerning the Cape Wind Energy Project Supplemental Environmental Impact Statement (SEIS). BOEM provided each tribe with an opportunity to be a cooperating agency during the preparation of the SEIS. None of the tribes elected to participate as cooperating agencies.

The Aquinnah, Narragansett, and Mashpee Wampanoag Tribes were provided with Section 106 Findings of No Historic Properties Affected for deploying buoys on two lease areas offshore Massachusetts, including the Offshore MW (Vineyard Wind) Site Assessment Plan (SAP); and the Bay State Wind SAP. These actions were undertaken as part of our programmatic agreements with the MA and RI State Historic POs and tribes for leasing and site assessment actions in the waters off those two states.

Alaska Region:

The Alaska Region conducted a combined total of <u>13</u> formal government-to-government tribal consultations and government-to-ANCSA Corporation consultations during FY 2017.

Gulf of Mexico Region:

The Gulf of Mexico Region (GOMR) did not conduct any official consultation meetings during FY17; however, the GOMR did contact the thirteen Gulf-affiliated tribes with requests for consultation in support of the Bureau's activities including development of the

Supplemental EIS for the proposed 2018 Gulf of Mexico Outer Continental Shelf Lease Sale (2018 Lease Sale EIS); the release of the Gulf of Mexico OCS Propose Geological and Geophysical Activities Final Programmatic EIS (Gulf G&G EIS); and the development of the 2019-2024 National OCS Oil and Gas Leasing Program (2019-2024 Program)

No responses were received from tribes on the 2018 Lease Sale EIS. Two responses were received on the Gulf G&G EIS: The Coushatta Tribe reviewed the document and concurred with its contents and decisions; the Choctaw Nation of Oklahoma indicated a general interest in projects impacting the coastal areas of Louisiana, Mississippi, and portions of Alabama and Florida, and requested to be consulted on any specific projects taking place in these areas. Two responses were also received on the 2019-2024 Program: The Muscogee (Creek) Nation indicated that the proposed program is within their historic area of interest and requested to continue participating in the program's development, including potential future consultations; the Choctaw Nation of Oklahoma indicated an identical concern and request.

No tribes requested formal consultations in GOMR. An informal discussion was held with the Choctaw Nation of Oklahoma to discuss the general concerns that were relayed in their responses to the Gulf G&G EIS and National Program 2019-2024 outreach efforts.

Pacific Region:

California offshore renewable energy: BOEM Pacific Outer Continental Shelf (POCS) Region consulted with one federally recognized tribe in support of its efforts related to California offshore renewable energy. The consultation request was initially related to the unsolicited lease request by Trident Winds, LLC, for a wind energy lease area off Morro Bay, CA. By the time the meeting took place, the topic also included the BOEM California Intergovernmental Offshore Renewable Energy Task Force.

While the BOEM Pacific Region only held one tribal consultation meeting during 2017 (above), in July 2017 the Region contacted almost eighty tribes along the Pacific west coast with requests for consultation in support of the Bureau's new National Offshore Oil and Gas Leasing Program. From that initial outreach effort, BOEM received responses from ten federally recognized tribes, one association of federally recognized tribes, and two non-recognized tribes. Five of the federally recognized tribes requested consultation. These meetings are expected to be held in FY 18.

II. Summarize and list all of the issues and recommendations.

Geological & Geophysical (G&G) Surveys on the OCS of the Atlantic

As part of the permitting process for G&G activities (following the BOEM G&G PEIS), BOEM reached out to the tribes with historical and current ties to the Atlantic. The Department is evaluating applications from six companies seeking permits to conduct G&G activities in the Atlantic Ocean. BOEM received responses from Penobscot Nation, stating they did not think it would affect resources they monitor; and Catawba Indian Nation alerting us to a change in address.

2019-2024 Outer Continental Shelf (OCS) Oil and Gas Leasing Program

BOEM sent a Program development letter inviting consultation at the Request for Information stage to all tribes identified with OCS coastal tribes. To date, the Delaware Nation has responded with "concurrence" to the Program and asks to remain informed. The Catawba Indian Nation and Tuscarora Nation also responded alerting us to changes in address.

Block Island Transmission System (Narragansett Indian Tribe)

On May 11, 2017 and August 16, 2017 consultation calls were held with the Deputy THPO (Mr. Doug Harris) of the Narragansett Indian Tribe related to wind energy projects and reparations for Block Island Transmission System BOEM granted the right of way for transmission) in state waters off of Rhode Island. BOEM was a cooperating agency on the environmental assessment, coordinated by the U.S. Army Corps of Engineers. BOEM leadership listened to Mr. Harris's position but does not have jurisdiction to negotiate reparations with the Tribe.

Atlantic Renewable Energy Programs

The primary goal of OREP's 2017 consultation is to seek input from tribal nations as part of our obligations under the National Historic Preservation Act and the National Environmental Policy Act. Future goals will be to continue meaningful and sustained consultation as the offshore wind industry moves forward in the waters off southern New England and New York.

The issues raised include concern for the effects to the natural environment as a whole, with particular concern for the future of right whales. All of the tribes noted a need for more tribal staff and resources to respond to increasing federal agency requests for consultation. Several tribes stated their desire to develop or enhance their own expertise in working with historic and natural resources. The challenge of describing the differences between consultation under NEPA and NHPA was also identified as an issue. The 2017 consultations helped to inform tribal governments about the upcoming offshore wind development off southern New England and New

York, and to strengthen the relationship between BOEM and the tribes for the future. Overall, the efforts in 2017 have broadened the foundation for future tribal consultation as wind energy is developed off the Atlantic coast.

As a part of its overall consultation policy, OREP has participated in teleconferences with the Narragansett Tribe to discuss the Tribal assertion that BOEM does not have the legal authority to issue leases on the OCS. Coordination with the SOL office is continuing on this issue.

Alaska Region

In general, concerns were varied. Among the general comments: Nearly every organization, whether representing a tribal government, ANCSA corporation, or local or regional government, was interested in the status of the current Five-Year Program and the potentials for the Proposed 2019-2024 Five-Year Program. Cook Inlet tribal tribes and communities were interested in Hilcorp activities, in view of the successful Lease Sale 244 (in Cook Inlet). Several entities expressed interest in learning more of BOEM's studies and how the results may apply for the Cook Inlet coastal areas. Both Tribes and ANCSA corporations underlined their attention and interests in preserving subsistence and working together with BOEM, other Federal and State agencies, and the energy industry in developing and working through safe practices for energy exploration and development. Another example, Cully Corporation (Point Lay) expressed concern about the restrictions of the uses of Ledvard Bay; a desire to develop their concept of what a potential Walrus set-aside area would look like for the annual Walrus haul-out that the critters take part in (near Point Lay). Virtually every tribe and ANCSA corporation encouraged continued engagement, sharing of information, applauding BOEM's advocacy for the uses of indigenous knowledge in decision making, and the increase in contacts.

Interest in BOEM's 2019-2024 Proposed Five-Year Program remains at a relatively high-level among tribal and ANCSA corporation representatives; it comes up during the course of any informal encounter, meeting, email exchange, or routine phone call. We continue to reference our BOEM website as a source of information, and use such opportunities to affirm our commitment to share updates as they come available.

Gulf of Mexico Region

The Choctaw Nation of Oklahoma expressed concerns for submerged cultural resources primarily within the 3-mile federal/state boundary. Projects in those areas are generally outside of BOEM's jurisdiction; however, BOEM agreed to notify the tribe should any prehistoric cultural resource discoveries occur in federal waters during agency activities. BOEM also agreed to continue notifying the tribe during each milestone of the development of the 2019-2024 Program.

Pacific Region

BOEM Regional Director, Joan Barminski, and technical staff met with the Elders Council of the Santa Ynez Band of Chumash Indians on 07 February 2017. BOEM provided background information on the Bureau's roles and responsibilities on the OCS, specifically focusing the discussion on offshore renewable energy. The tribe asked many questions about the Trident Wind application and about offshore renewable energy, in general (Trident Wind application and CA Intergovernmental Task Force). They expressed concerns over impacts to migratory species, including birds, fish, and marine mammals. The tribe also had questions about the proposed technology, including siting, construction, mooring, and energy transfer. No specific issues or recommendations were identified during the meeting.

III. Summarize successes and accomplishments and include recommendations for improvements to the consultation process.

The timeline for reaching out to tribes during the 2019-2024 National Program was designed in order to closely parallel outreach to stakeholders as a part of the public meeting schedule. Therefore, outreach to federally recognized tribes is occurring much earlier than in previous Program development to give tribes more time to learn about the Program, prior to decision making.

The consultation meeting between the Santa Ynez Band of Chumash Indians and the BOEM POCS Region was a success, in that it provided an opportunity for the POCS Regional Director to meet with representatives from the nearby Santa Ynez Band of Chumash Indians. It also provided the tribe an opportunity to learn more about the roles and responsibilities of the Bureau and expected activities related to offshore renewable energy development. Additionally, the meeting provided an opportunity for the Region and the tribe to identify protocols for continued communication and future consultation. Recommendation: Support for in-person meetings is necessary to begin and continue the communication process and for each to learn of the topics, background and needs of each group.

The Alaska Region continued leading an effort in placing high value on obtaining and use of traditional indigenous knowledge for studies, research, and notably decision-making considerations among scientists, educators, and international organizations (through the auspices of the Arctic Council). The Region also continued active efforts to 'return and report' to communities about the uses and applications of traditional / indigenous knowledge identifying the power and value of such input.

Alaska OCS Region' Studies Section completed two significant outreach efforts with distribution of *The Alaska Arctic Marine Fish Ecology Catalog*, and *The Social Indicators in Coastal Alaska: Arctic Communities Study*. Each study, individually, was met with extraordinarily positive receptions among tribal leaders and organizations. They directly supported the village of Kaktovik Annual Summer

Science Camp again and has remained actively engaged with the Alaska Science Teachers Association providing support; and with placing 'Scientists in the Classroom' program with the Anchorage School District and the Alaska Marine Science Symposium.

The University of Alaska Anchorage - Alaska Native Science & Engineering Program (ANSEP) recognized BOEM-Alaska OCS Region with two 'Baleen Awards' for BOEM's continuing outreach and support to rural youth. The recognition was for the extended efforts BOEM has made over more than five years in working with youth and developing STEM opportunities with the University of Alaska and in selected public schools. BOEM was successful with getting two Position Descriptions approved for Pathways Interns for petroleum engineer and geologist (for the BOEM Alaska Region); this effort is meant to encourage recruitment for qualified students and graduates. The University of Alaska Anchorage ANSEP provides an increasingly ready pool of potential engineers and scientists.

Alaska Region expanded its efforts to increase the number of ANCSA Corporations – both Regional and Village – that may wish to more fully participate and engage with the agency.

The Alaska Region is leading an effort in developing several levels of new tribal relations training to improve the consultation processes for both employees and those with whom the agency commits to consult with. The training is inclusive and has potential transportability.

The Tribal Liaison Officer has developed an updated Policy Guidance document that has been reviewed by the BOEM Tribal Working Group and senior management. Additional edits and review are expected at the conclusion of the GAO Tribal Consultation audit based on the recommendations. BOEM expects to consult with tribes on the policy after it is initially adopted and the development of a more indepth best practices handbook as BOEM strives to ensure consistent and meaningful consultation across Regions and Program Offices.

Participated in GAO Tribal Consultation audit and will implement recommendations into the proposed updated tribal consultation guidance.

Jennifer Ewald (OEP) and Richard Warner (OREP) participated in a meeting on November 15, 2017 organized by EPA and NOAA to discuss and review how various federal agencies carry out their federal tribal trust responsibility with the New England Tribes. Follow up meetings are planned to include tribal representatives.

IV. Outreach Efforts

BOEM is continually working to inform tribes of actions that may cause impact. This list was derived from available data sets, historical records, tribal treaties and

communication efforts to identify those tribes with both current and historical connections to the coastal regions along the outer continental shelf. This list will be updated for FY18 with newly identified tribes and newly federally recognized tribes.
