Year 2005 Gulfwide Emissions Inventory Study

OCS Study MMS 2007-067

The Minerals Management Service (MMS), Gulf of Mexico OCS Region, announces the availability of a new study report, *Year 2005 Gulfwide Emissions Inventory Study*.

This study report describes the calendar year 2005 emissions inventory of oil and gas activities on the Outer Continental Shelf. These emissions influence the ambient concentrations of ozone, haze material, and visibility, and include carbon monoxide, sulfur dioxide, nitrogen oxides, particulate matter, and volatile organic compounds. Not only are these criteria pollutants covered in this inventory, but greenhouse gas estimates were calculated as well. The MMS collected activity data from active offshore oil production platforms and non-platform sources in the Central and Western Gulf of Mexico. Operators were provided with the Gulfwide Offshore Activities Data System (GOADS-2005) collection software for compiling monthly data for calendar year 2005. Nearly 1,585 major oil and gas production platforms submitted monthly equipment activity data files. Non-platform sources included pipelaying vessels, drilling vessels, and support helicopters and vessels. Rigorous quality assurance/quality control (QA/QC) activities were performed on the activity data collected from platform operators. The report describes the methodologies used in collecting and compiling the inventory into a database. The database is available upon request for use in air quality modeling efforts. When reviewing the results of the Year 2005 Gulfwide Emission Inventory Study, it is important to keep in mind the widespread damage in the Gulf of Mexico caused by Hurricanes Katrina and Rita, which impacted the inventory results for September through December.
