Applications for Renewable Energy Leases and Grants and Alternate Use
Grants on the U.S. Outer Continental Shelf

This Notice to Lessees, Operators, and Applicants (NTLA) supersedes NTLA No. REN-N01 on this subject. It updates the jurisdiction and office address of each Bureau of Ocean Energy Management (BOEM) Regional Office where applicants should file for renewable energy leases and grants and alternate use grants on the U.S. OCS.

### Background

On April 22, 2009, President Obama announced that the Department of the Interior finalized the framework for renewable energy production on the OCS. A final rule, published in the Federal Register on April 29, 2009 (74 FR 19638), establishes a program to grant leases, rights-of-use and easement (RUEs), and rights-of-way (ROWs) for orderly, safe, and environmentally responsible renewable energy and alternate use activities, such as the siting of offshore wind facilities on the OCS.

#### Filing Addresses

Applications for renewable energy leases, RUEs, and ROWs and alternate use RUEs on the OCS are to be filed with the appropriate BOEM Office as outlined below.
