LEASE EXTENSION REQUESTS: To earn the extension of the initial period, all requests should be submitted from the **Lessee** and not the **Operator**. Please refer the Lease Addendum attached with the subject lease documents. The request should be submitted as soon as practicable, but in no case more than 30 days after spudding a well. The BOEM GOM Regional Supervisor for Leasing and Plans will confirm in writing, within 30 days of receiving the **Lessee's** letter, whether the **Lessee** has earned the extension of the initial period and update BOEM records accordingly. The extension of the initial period is not effective unless and until the **Lessee** receives confirmation from BOEM.
