Consultation & Coordination with Indian Tribal Governments (EO 13175)



- Recognize that federally-recognized Indian tribes have concerns relating to wind energy leasing in the AMI
- There may be potential impacts to sacred and ceremonial sites, and inundated sites on ancestral lands
- Will request formal government-to-government consultations to:
 - learn about these concerns
 - create the foundation for future consultations under NHPA Section 106

National Historic Preservation Act (NHPA)



- Recognize Indian tribes possess specialized expertise in assessing the eligibility of historic properties that may possess religious and cultural significance
- Conduct Section 106 consultations on a government-to-government basis in recognition of the unique legal relationship with Indian tribal governments

National Historic Preservation Act (NHPA)



- Carry out consultations in a manner sensitive to tribal needs and concerns;
- Begin with the publication of the Notice of Intent to Prepare NEPA compliance
 - Announces the preparation of analysis for lease issuance, site characterization, and site assessment activities;
 - Consistent with the beginning of other statutorily-mandated consultations

Endangered Species Act



- Prepare Biological Assessment (BA) covering potential effects from leasing and site assessment and characterization activities on endangered and threatened species
- Consult with National Marine Fisheries Service and U.S. Fish and Wildlife Service.
- Services will provide BOEMRE with a Biological Opinion (BO) within 135 days of receipt of the BA
- BO may have additional binding mitigation measures for the project to reduce impacts on endangered and threatened species.

Magnuson-Stevens Fishery Conservation & Management Act



- Prepare an assessment of the impacts of leasing and site assessment and characterization activities on Essential Fish Habitat (EFH)
- Consult with the National Marine Fisheries Service regarding potential impacts to EFH
- National Marine Fisheries Service may recommend further mitigation measures to reduce impacts on EFH





- Grants exclusive right to submit plans
- Does not authorize construction
- Only reasonably foreseeable activities are site assessment and site characterization activities
 - Meteorological buoys or towers
 - May include archaeological, biological, geophysical, geotechnical, and shallow hazard surveys

Smart from the Start Atlantic Wind Initiative



- Use RFIs and Calls to refine and modify to delineate a WEA and inform both our NEPA and lease issuance processes
 - Streamline NEPA: Start with an environmental assessment to evaluate potential impacts from renewable energy lease issuance
 - EA will only analyze site characterization and assessment activities
 - Other approaches (e.g., anticipate significant impacts, AOWEC RI pilot)
