NORTHSTAR UNIT RESIGNATION OF UNIT OPERATOR AND DESIGNATION OF SUCCESSOR OPERATOR

This Agreement, entered into this 12th day of January, 1995, among Amerada Hess Corporation ("Amerada"), Shell Frontier Oil & Gas Inc. ("Shell"), Murphy Exploration & Production Company ("Murphy") and BP Exploration (Alaska) Inc. ("BPXA"), hereinafter referred to collectively as the "Parties" or individually as the "Party".

WHEREAS, Amerada is the Operator of the Northstar Unit, Beaufort Sea, Alaska;

AND WHEREAS, Amerada intends to resign as Operator;

AND WHEREAS, BPXA has agreed to succeed Amerada as Unit Operator of the Northstar Unit;

NOW THEREFORE, in consideration of the covenants and agreements herein contained, the Parties agree as follows:

- 1. Amerada hereby resigns as Operator of the Northstar Unit pursuant to Article 10.002.01 of the Northstar Unit Operating Agreement and Article 5.1 of the Northstar Unit Agreement.
- The Parties agree that BPXA shall succeed Amerada as Operator of the Northstar Unit.
- 3. Amerada's resignation and BPXA's succession as Unit Operator shall be effective ("Effective Date") upon approval of the United States Department of the Interior Minerals Management Service Regional Supervisor and the Commissioner of the Department of Natural Resources, State of Alaska. BP Exploration (Alaska) Inc.'s address for notification is:

- 4. Upon the Effective Date of Amerada's resignation, and in accordance with Article 5.4 of the Northstar Unit Agreement, Amerada relinquishes, if applicable, all wells, artificial islands, installations, devices, records and any other assets used for conducting unit operations.
- 5. Pursuant to Article 6.1 of the Northstar Unit Agreement, BPXA, as successor, accepts the rights and obligations of the Northstar Unit Operator.

6. This Agreement may be executed as one instrument or in counterparts, no one of which need be executed by all Parties, with the same force and effect as if all Parties had signed the same document.
