Having an excellent knowledge of federal Indian law, which is complicated and guite extensive, I have concerns about the "tribes" you are going to consult regarding this plan. While there are a number of Indian or Native American groups on the Atlantic seaboard, there are very few legal entity tribes. No one who is a member of other than a federally acknowledged, or recognized, tribe should be considered as a tribe for purposes of this plan. Members of Indian groups who are not federally recognized are not legally Indians under the Constitution and federal statutory law. Members of such groups may or may not have Indian ancestry, but are now ordinary citizens like any other American citizen and should be given no special preference in terms of input for this plan and its implementation. State "tribes" are not legally tribes or Indians under federal laws. Indians (members of a recognized tribe) have a special, protected status under the Constitution and federal statutory laws and should be recognized as the only legitimate Indians or tribes as such. Individuals with Indian ancestry are not legally Indians unless they are enrolled members of federally recognized tribes. Tribes and their members have a special and unique status in American law. It concerns me that many Native Americans, who are not legally Indians under federal laws, which are the only laws that govern Indians and tribes in the U.S., are being given voice as though they were members of a legally recognized Indian tribe. Individuals are not recognized as Indians under federal laws and statutes. Being an Indian confers special status under American laws as noted, and doesn't even rely on any specific blood quantum of Indian ancestry, but on membership in a political/economic entity with uninterrupted organizations meeting these qualifications since initial contact with Europeans. Tribes cannot be re-formed once they have ceased to exist. Likewise, every tribe sets it's own blood quantum required for enrollment as a member of the tribe. As I stated, its quite complicated and you would do well to contact the Bureau of Indian Affairs for an official list of Indian tribes in the United States. Anyone other than an enrolled member of one of these tribes is not legally an Indian or member of a tribe, and are, in fact individual citizens regardless of any Indian ancestry they may or may not have. Please educate the members of your group about these matters and act accordingly.

Dear Mr. LaBelle:

It was nice to have you at our table for the MidA RPB meeting in Baltimore yesterday. It is good to see that your marine biology background gives an additional perspective to your current responsibilities.

Please accept these formal comments on the Draft Mid-Atlantic Regional Ocean Planning Framework. I am very concerned that Ocean Planning will not be as efficient as it could and should be under the current plan. My understanding from the start was that Ocean Planning would rely on early input from each of the ocean's current and future user groups to provide an efficient, 'all at the same table' means of working together. The desired result being to discuss each sector's needs and priorities in an attempt to find a solution that works for everyone thereby reducing cost and potential conflicts.

Since the initial siting of some projects appears to be taking place without stakeholder input I thought it would be good to look at the intent of the Executive Order that initiated Ocean Planning, EO #13547.

The order states: "This order adopts the recommendations of the Interagency Ocean Policy Task Force except where otherwise provided in this order, and directs executive agencies *to implement those recommendations* (emphasis added) under the guidance of the National Oceans Council."

I then went to the 'Final Recommendations of the Interagency Ocean Policy Task Force' to see what they intended as stakeholder/public participation.

In the Final Recommendations, (see attached notes) there are more than 15 references to public and/or stakeholder participation. In at least four of those, it calls for stakeholder and public engagement *throughout* the planning process.

It also encourages "broad public participation."

I do not believe that simply providing data for the Portal can be construed as the intended stakeholder or public engagement. It appears to me that the intent was for this to be an open and public process, without any particular agency having exclusive power over siting or any other aspect of ocean planning.

I understand that the public was informed at a recent public meeting on the NY offshore wind farm that the location and size of the farm was set and there would not be any modifications. This does not appear to follow the intent of the Final Recommendations and it definitely does not meet the public's expectation to have their interest considered.

Please reconsider the amount of representation that the public expects to have and consider changing the plan to provide the level of input by the stakeholders that was apparently intended by the Task Force. This lack of public input in the initial siting undercuts the efforts of the Stakeholder Liaison Committee members to encourage public support for this process. I doubt that I could get any of the NY meeting attendees to write letters to their Congressional representatives in support of the current Ocean Planning format. We do not expect to have the final say in the initial siting but believe we have the right to comment and have those comments considered along with those of other users.

I thank you for your commitment to this project. A formal Ocean Planning process certainly appears to me to be the best way to address the upcoming pressures on our ocean.

In this way, regional objectives and national objectives, goals, and guiding principles can be considered in a single, comprehensive, and integrated process. RE: Request for Suspension and Extension of Comment Period

Dear Mr. LaBelle, Ms. Schultz, and Ms. Leonard:

The National Ocean Policy Coalition ("Coalition") formally requests a suspension and extension of the comment period on the draft Mid-Atlantic Regional Ocean Action Plan ("Plan") that the Bureau of Ocean Energy Management released on July 6, 2016 for 60 days of public comment.¹ For the reasons stated below, the Coalition specifically requests that the Mid-Atlantic Regional Planning Body ("RPB") suspend the current comment period and re-open it for 90 days after information critical to meaningful comment is made available.

The need for a suspension and extension is based on several factors. First, the July 6 *Federal Register* announcement noted that the "specific manner and mechanism a Federal agency uses to implement the final Mid-Atlantic Ocean Action Plan will depend upon that agency's mission, authorities, and activities in the marine environment," adding that federal RPB members "will publicly describe the administrative mechanisms they will use to implement the Plan when the MidA RPB submits the Plan to the [National Ocean Council] for review and concurrence."

Thus, the regulated user group community and others are being asked to provide comments without critical details on how federal entities specifically intend to implement and execute the Plan. Informed comments on the draft Plan cannot be provided in the absence of such information. The need for the

information is underscored by the fact that the comment period involves the review of a Plan that upon approval would be implemented by eight federal agencies and departments and their component subagencies, six states, two federally-recognized tribes, and the Mid-Atlantic Fishery Management Council.

The need for additional time is further highlighted by the National Ocean Council's marine planning guidance, which among other things states that "regional planning bodies will promote informed public participation and operate with transparency" and that a "cornerstone of marine planning, and of the work of regional planning bodies, is the engagement and substantive participation of stakeholders and the public."²

Without critical details on how RPB entities intend to implement and execute the plan, it is simply not possible to provide informed comments on the proposal.

Furthermore, 60 days is insufficient to provide informed comments on the release of the first-of-its-kind Mid-Atlantic Regional Ocean Action Plan, major components of which are based on implementation of marine life and habitat mapping products that were not publicly accessible on the Mid-Atlantic Ocean Data Portal ("Portal") until August. To this date, the Portal still does not contain the full suite of marine life and habitat mapping products referenced in the draft Plan, including individual species base layer maps and associated uncertainty products, and maps depicting species diversity.

While the Coalition disagrees with the National Ocean Council imposition of a maximum 90-day comment period for draft marine plans,³ it recognizes the directive that has been imposed on RPBs and urges the Mid-Atlantic RPB to utilize the full 90 days to facilitate more informed user group and stakeholder engagement during the public comment period on the draft Plan.

In addition, to ensure that the public has an opportunity to provide informed comments on the draft Plan and its associated products, including the vital details on how federal entities intend to implement and execute it, the comment period should be suspended until such time as all such information is made publicly available. At that point, a 90-day public comment period should start anew.

Our region's ocean is also an economic powerhouse, contributing more than \$48 billion to the region's gross domestic product (GDP) and nearly 700,000 jobs. And offshore waters serve as migratory corridors and a home for ocean life, including endangered North Atlantic right whales, sea turtles, and many fish species.

As our ocean faces growing challenges of pollution, loss of habitat, and competing industrial uses, it's critical the Mid-Atlantic Regional Ocean Action Plan ensure a healthy ocean today and in the future. I applaud the RPB on its work to complete this first-ever draft Ocean Action Plan. I hope you will incorporate these recommendations below that will make this Plan stronger and more reflective of me, as an ocean user and coastal citizen.

The Final Ocean Action Plan must:

- Develop a robust and effective process for engaging stakeholders in Plan implementation. Right now the draft Plan's public involvement strategies are vague and variable. Stakeholders, project proponents and agencies will all benefit through a consistent, uniform engagement strategy.

- Set a short, definitive deadline - ideally by the end of this year - to identify and post on the Mid-Atlantic Ocean Data Portal areas offshore that are important for the health of marine life (ecologically rich areas or ERAs).

- Strengthen Federal agency commitments to the Plan's tools for coordinating agency decisions. It is unacceptable that even a few actions outlined in the draft Plan do not have a lead federal agency or tasks the entire RPB with overseeing implementation.

With these additions to the Plan, I know our region will take a big step forward toward a healthier Atlantic Ocean.
