## Estimated Oil and Gas Reserves Gulf of Mexico Outer Continental Shelf, December 31, 2006

## **OCS Report MMS 2009-064**

The Minerals Management Service (MMS), Gulf of Mexico OCS Region, announces the availability of a new report, *Estimated Oil and Gas Reserves*, *Gulf of Mexico Outer Continental Shelf, December 31, 2006*.

This report presents estimated proved reserves, cumulative production, remaining proved reserves, and unproved reserves as of December 31, 2006. Proved reserves were estimated to be 12.30 billion barrels of oil and 183.6 trillion cubic feet of gas from 1,229 in proved fields under the Federal submerged lands in the Gulf of Mexico OCS. Of these 1,229 fields, 273 were depleted and abandoned; not included were 59 unproved active fields. Cumulative production from the 1,229 proved fields was 15.08 billion barrels of oil and 166.7 trillion cubic feet of gas.

The remaining proved reserves were estimated to be 5.22 billion barrels of petroleum liquids (both oil and natural gas condensate) and about 16.9 trillion cubic feet of natural gas in 956 proved active fields of the Gulf of Mexico OCS. This report indicated an increase of about 0.03 billion barrels of liquid (oil and gas condensate) and a decrease of 1.0 trillion cubic feet of gas in remaining proved reserves as compared with the December 31, 2005, estimates.

Unproved reserves were estimated to be 4.44 billion barrels of oil and 8.3 trillion cubic feet of gas. These reserves include unproved reserves from proved and unproved active fields. There were 59 unproved active fields. In summary, there are 1,015 active fields located in the Gulf of Mexico OCS.
