The Bureau of Ocean Energy Management (BOEM) acknowledges receipt of the Commonwealth of Virginia, Department of Mines, Minerals, and Energy's (DMME) Outer Continental Shelf (OCS) Renewable Energy Lease or Grant Designation of Operator form submitted on March 16, 2015, to designate Virginia Electric and Power Company as lease operator of research lease OCS-A 0497.

BOEM regulations at 30 CFR 585.405, require that a lease operator, who is not the Lessee, be identified in the Lessee's Site Assessment Plan, Construction and Operations Plan, or General Activities Plan, as applicable. The Office of Renewable Energy Programs has prescribed a departure from this requirement pursuant to 30 CFR 585.103(a)(1) to allow Virginia Electric and Power Company to be designated lease operator prior to plan approval for research lease OCS-A 0497. First, it was established by DMME during lease negotiations that designation of an operator is necessary for DMME to fulfill its obligations as Lessee; therefore, the departure facilitates the issuance of the subject lease, which in turn facilitates the appropriate activities on the lease. Second, the departure is consistent with subsection 8(p) of the Outer Continental Shelf Lands Act. Third, the departure protects the environment and the public health and safety to the same degree as if there was no approved departure. Fourth, the departure does not impair the rights of third parties. Accordingly, the Designation of Operator is hereby approved and will become effective April 1, 2015.

The Regional Supervisor or his representative may serve the designated operator written or oral instructions in securing compliance with the applicable regulations. This designation of operator is made with respect to the block(s) and/or aliquot part(s) described in Exhibit "A" attached hereto and made a part hereof.

It is understood that this designation of operator does not relieve the lessee or grantee of responsibility for compliance with the terms of the lease, grant, laws, and applicable regulations. It is also understood that this designation of operator does not constitute an assignment of any interest in the lease or grant. In case of default on the part of the designated operator, the lessee or grantee will make full and prompt compliance with all regulations, lease terms, or orders of the Secretary of the Interior or his representative. If there is a change in the designated operator, the lessee or grantee must provide written notice to the Regional Supervisor and identify the new designated operator within 72 hours. The lessee or grantee is the operator and responsible for compliance until BOEM approves designation of the new operator. The designated operator shall comply with the Department of the interior's nonprocurement debarment and suspension regulations as required by 2 CFR Part 1400 and shall communicate the requirement to comply with these regulations to persons with whom it does business related to this designation by including this term in its contracts and transactions.
