other ocean uses, they are also linked to land-based transportation needs."2

BOEM clearly states the importance of shipping to the United States of America and then later in the report disregards shipping for unidentified competing uses.

"Regularly updated, detailed analyses of vessel traffic data over discrete time periods should demonstrate whether certain types of shipping are affected seasonally and/or on a long-term basis. This will allow decision makers to better time planned restrictions on, or potential disruptions to, shipping lanes when coordinating competing ocean uses."3

It is disheartening that BOEM would even consider disrupting vital sea-lanes? What competing uses? Our Nations GDP is directly linked to Trade. When Trade goes up so does our Nations GDP. BOEM consider disrupting shipping lanes they must be prepared for negative impacts to our Nations GDP and net negative energy management from unnecessary additional vessel fuel burn.

investments in dredging projects and may require changes in ports, including realigning channels and modifying anchorages and turning basins. Providing planners and decision makers with anticipated shifts in vessel trends leads to better characterization of navigation needs of and risks posed by marine commerce. This action will identify impacts to navigation and port infrastructure stemming from the expansion of the Panama Canal by monitoring trends and marine traffic patterns, assessing impacts to marine commerce disruption or rerouting measures, and assessing coastal approaches against proposed port depths."⁴

Larger ships are already entering Ports on the East Coast and the ripple is surging. Shifting manufacturing centers ship significant levels of cargo via the Suez Canal NOW impacting rail and road cargo movements that are being pushed to cargo limits.

Marine Transportation will be relied upon to move cargo to facilitate trade. New Articulated Tug Barge (ATB) technology, the nations leading Ocean transporter of liquid and dry bulk, will be called upon to move cargo meeting current and future volumes of trade.

In Ocean Planning, BOEM must heed first to all current and future trade routes to protect our nations trade and economy. Our nation depends on trade and navigation safety must be protected.

Thank you for such a quick response. I understand the convenience factor. When it gets to the brass tacks of understanding the science, SE Virginia is quite a different place than Northern Virginia, et al. We've had decades of irresponsible plant use here (and biome classification), promoted in media writing and garden/landscape writing (many from folks not from here and not familiar with our area), namely recommending many northerly cool climate species (among landscape trees and shrubs) like Fescue lawngrass for our landscapes, a highly detrimental species with associated care that set back our rivers and waters I am sure for 5 decades. What grows on land is directly tied to the waters. These erroneous recommendations, almost foisted on unknowing recipients, have easily caused us a world of confusion. I hope you can make a note in your future work with this planning body when it comes time for details.

The addition of the state of Virginia to the geographical scope covered by Radford, Ahles, & Bell offers a number of advantages. The four-state region is a compact and relatively natural unit; Virginia, with its strong representation of Southern Aappalachian and Southeastern Coastal Plain species, has stronger floristic affinities to the Carolinas than to states to its north and west, with which it has often been treated in the past (as in Fernald, Gleason & Cronquist, etc.). The four-state coverage will provide botanists working primarily in one state with a greater regional perspective, and should promote an increased knowledge of each state's flora, by making readily available information on species nearby."
