November 20, 2014

- End of public comment period.

2015 – 2016

January 21-22, 2015

- RPB meeting to make a decision about structure and content of a regional ocean action plan and other RPB workflows.

Remainder of 2015 and 2016

- Early 2015, workplan developed to guide development of regional ocean action plan throughout 2015 and 2016.
- In-person public RPB meetings held 2-3 times per year, with accompanying public comment periods and other opportunities for public engagement as appropriate.
- First iteration regional ocean action plan under review by the National Ocean Council: targeting late 2016.

2017 and Beyond


2017

- Implementation of regional ocean action plan.
- Refinements to regional ocean action plan identified and incorporated.

Note: Implementation means carrying out existing mandates and authorities in the context of and informed by a consensus-based regional ocean action plan, which will be periodically updated by the RPB to account for new information/technology.

Continuous: Stakeholder Engagement, Data Collection/Sharing/Integration, and Refinement of Products and Processes

Options for a Mid-Atlantic Regional Ocean Action Plan




Our Mid-Atlantic Regional Ocean Action Plan should:

- Inform decision making under existing authorities to enhance current management of the ocean
- Build on existing partnerships and planning efforts in the Mid-Atlantic
- Be designed and implemented with robust stakeholder input
- Satisfy diverse stakeholder interests
- Be updated over time to reflect new information and changing conditions.


Five options considered

- *Option A: Issue-Triggered Coordination Process*
- *Option B: Compatibility Assessment*
- *Option C: Targeted Coordination by Issue or Geography*
- *Option D: Compatible Use Areas*
- *Option E: Comprehensive Optimal Use Maps*

Relative practicality of options



Mid-Atlantic RPB assessment of options

- Options A and E impractical:
 - Option A would require addressing issues on a case-by-case basis and not result in sufficient improvement over the status quo.
 - Option E may be very time-consuming and costly
- The MidA RPB considers the other three options to be more practical and would like to further refine:
 - Compatibility Assessment (option B)
 - Targeted Coordination by Issue or Geography (option C)
 - Compatible Use Areas (option D)




Interim Stakeholder Engagement Plan



Interim Stakeholder Engagement Plan

- Precursor to stakeholder engagement component of the MidA Regional Ocean Action Plan workplan
- Outlines MidA RPB's goals, objectives, and approach to stakeholder engagement
- Offers options for participation
- Provides specific topics on which RPB members will be gathering input from stakeholders
- Outlines wide range of tools and methods for discussion by the RPB and stakeholders

MidA RPB approach to stakeholder engagement

- 
- Work closely with stakeholders
 - Directly and in coordination with others
 - In meaningful and efficient ways
 - Using a multitude of approaches

Important considerations

- Mid Atlantic already home to:
 - Top-notch experts focused on healthy ocean ecosystems and sustainable ocean uses;
 - Ongoing processes relevant to ocean planning;
 - Organizations with stakeholder engagement capacity and robust communication channels
- Resource constraints may limit RPB-specific additional activities



Status of the Regional Ocean Assessment (ROA): *Outline and Template for Content*



What is an ROA?

- A Regional Ocean Assessment (ROA) is a compilation of the best available physical, biological and socio-economic information about a region of the ocean.
- Purpose of an ROA:
 - Capture and characterize the current ecological and human use state.
 - Understand the condition and use of that area to guide planning for a desired future direction.




What is the Mid-Atlantic ROA?

- The ROA is being developed to inform the RPB's Regional Ocean Action Plan.
- Built upon the RPB's Framework goals and objectives.
- Will contain existing best-available data, information, and maps about baseline conditions, resources, and uses.
- Will identify trends, data gaps, and address future uses to the extent possible.
- Envisioned as an online tool with links and other sources of information; continually updated with current information as the Regional Ocean Action Plan is developed.

Status of the Mid-Atlantic ROA

- Currently in Phase 1 of development.
- Gathering feedback from stakeholders on the structure, topics, and proposed content of the ROA.
- Provide an outline and a template of the ROA content to be collected.

Regional Ocean Assessment

Introduction

The ocean and coastal waters of the Mid-Atlantic, stretching from New York to Virginia, is rich in resources and is valued by a wide array of users. Vast migration corridors, deep submarine canyons, and the convergence of cool New England and warm South Atlantic waters are some of the diverse characteristics that shape this part of the ocean. These unique features support a rich diversity of marine life, including marine mammals, seabirds, sea turtles, sharks, marlin, and an array of fish, shellfish and crustaceans that have great economic and recreational value.

Proposed ROA topics

The ROA outline focuses on specific topics where there is potential overlap between marine resources, habitats, and ocean uses.







Coastal Recreation Survey





Wildlife Viewing (example)




