



Overview of New York Milestones

Per Competitive Leasing Process outlined in 30 CFR 585

- Unsolicited commercial nomination received Sept. 28, 2011
- Request for Interest (RFI) January 4, 2013
- Call for Information and Nominations (Call) and Notice of Intent to Prepare an Environmental Assessment (EA) – May 28, 2014
- Area Identification (Area ID) completed March 16, 2016
- Notice of Availability of EA June 6, 2016
- Proposed Sale Notice (PSN) June 6, 2016
- Final Sale Notice (FSN)
- Lease Sale




National Environmental Policy Act (NEPA)

NEPA is a procedural law that requires Federal agencies to assess the environmental effects of their proposed action(s), and reasonable alternatives, prior to making decisions.

Major Actions/Decision Points

- Lease Issuance (Survey Work)
- Plan Approval (Site Assessment, Construction and Operation, or General Activities)
- Decommissioning Activities



What is an Environmental Assessment (EA)?

- An EA is a concise public document which:
 - Briefly provides sufficient evidence and analysis for determining whether to prepare an Environmental Impact Statement (EIS);
 - Aids an agency's compliance with NEPA when no EIS is necessary (better alternatives and mitigation measures) and;
 - Facilitates preparation of an EIS when one is necessary.

New York Environmental Assessment

- Notice of Availability published on June 6, 2016 (Docket No. BOEM-2016-0038)
- 30-day public comment period (ending July 6, 2016)



Proposed Action: What is considered

- Lease Issuance
- Associated site characterization surveys
- Subsequent site assessment activities




Proposed Action: What is NOT considered

- Installation, operation, and decommissioning of a commercial wind energy facility
- If an eventual lessee were to submit a construction and operations plan, BOEM would conduct a project specific environmental analysis that would likely take the form of an EIS

Other Alternatives

- Alternative B Leasing of the Whole WEA, Restricting Site Assessment Structure Placement within 2 NM of a TSS
- Alternative C No Action
- Others alternatives were considered but not analyzed in the EA as they did not meet the purpose and need and/or they were not reasonable. These are outlined in Section 2.4 of the EA



Impact Producing Factors

Environmental Lease Stipulations



*Additional Construction or Operations Stipulations May Be Added As Terms and Conditions of Plan approval

EA Findings

- For most resources, reasonably foreseeable impacts were negligible to minor.
- Potential moderate impacts identified for marine mammals and sea turtles
 - Only result from noise related to pile driving (i.e., meteorological tower construction)
 - SOCs developed to minimize or eliminate these potential impacts
- No reasonably foreseeable significant impacts are expected to occur as a result of the proposed action

 - Issues a Finding of No Significant Impact or;
 - Prepare an EIS
