

NEW YORK INTERGOVERNMENTAL RENEWABLE ENERGY TASK FORCE MEETING OCTOBER 3, 2017 MEETING SUMMARY

MEETING IN BRIEF

At its October meeting, the New York Intergovernmental Renewable Energy Task Force and the public heard updates on recent offshore wind leasing activities in the New York region. Lessee representatives presented status updates for the Statoil Project and the South Fork Project and took questions from Task Force members. New York State (NYS) representatives presented on the *Area for Consideration* identified in a draft chapter of the NYS Offshore Wind Master Plan, released on October 2. The Task Force also discussed the Bureau of Ocean Energy Management (BOEM)'s plans for future leasing in the Atlantic, an upcoming Call for Information and Nominations (Call), and BOEM's efforts to strengthen stakeholder outreach and Task Force engagement. The meeting provided two opportunities for public input on topics being considered by the Task Force. ATTENDANCE

Approximately 25 Task Force members attended the meeting, including federal, tribal, state, and local representatives (attendee list attached). In addition to Task Force members and BOEM staff, representatives from the states of Rhode Island, Massachusetts, and New Jersey participated to foster a more integrated consideration of regional issues. Approximately 50 members of the public attended the meeting including representatives from the fishing industry, environmental NGOs, and the wind energy industry. Representatives from BOEM lessees Statoil and Deepwater Wind also participated in the meeting.

DISCUSSION

Below is a summary of key themes and topics discussed at the meeting.

Welcoming Remarks

James Bennett, Chief of BOEM's Office of Renewable Energy Programs (OREP); Alicia Barton, President and CEO of NYSERDA; and Kisha Santiago-Martinez, New York Deputy Secretary of State, Office of Planning and Development, offered welcoming remarks to the Task Force and the public. The speakers noted the strong competitive interest on the East Coast and NYS' ambitious commitment to build 2.4 gigawatts of offshore wind power by 2030.

BOEM Overviews – Recent and Future Activities

BOEM staff presented on recent and future activities in the New York region:

<u>Commercial renewable energy lease activities offshore NYS</u> – Luke Feinberg, BOEM Project Coordinator, reviewed BOEM's leasing process and provided status updates on the eight leases and three unsolicited applications in the region. The presentation underscored the extensive activity along the outer continental shelf.



- <u>Post-lease surveys and studies</u> Isis Johnson-Farmer, BOEM NEPA Coordinator, and Brian Hooker, BOEM Marine Biologist, described how data collected through surveys and studies feed into guidelines and lease stipulations for lessees and inform BOEM's review of a Construction and Operations Plan (COP).
- Next steps in leasing process Luke Feinberg and Isis Johnson-Farmer reviewed the procedural steps between a Call for Information and Nominations and a lease auction. BOEM is targeting a Call by the end of 2017 and an auction in 2019. It is seeking input from Task Force members on Call size, location, and the extent to which BOEM should incorporate the *Area for Consideration* identified by NYS.
- <u>Task Force assessment</u> CBI Facilitator Bennett Brooks briefly reviewed findings from a series of interviews CBI conducted with Task Force members nationwide to assess overall Task Force effectiveness. James Bennett then shared BOEM's current thinking on specific strategies it is already pursuing or likely to pursue to improve Task Force coordination. Task Force members generally voiced support for the intended changes.

Industry Project Updates - Statoil and South Fork

Christer af Geijerstam, Project Director with Statoil, and Aileen Kenney, Vice President of Permitting and Environmental Affairs with Deepwater Wind, provided updates on their respective leases: the Statoil Project and the South Fork Project. The presentations included information on their companies, the proposed developments and associated timelines, future survey work, and intended approaches to stakeholder outreach. Task Force member questions and remarks focused on (1) the importance of proactive outreach (to both agencies and stakeholders), (2) opportunities for work force training and port revitalization, and (3) the potential for coordinating transmission cable routing to minimize impacts.

New York State Updates

NYS representatives provided an update on the state's efforts to develop offshore wind resources in order to meet its 2030 renewable energy goal. State representatives reviewed some of the studies undertaken to highlight potential use conflicts and identify promising areas for offshore wind energy development. On October 2, NYS submitted to BOEM an *Area for Consideration* composed of an East Area and a West Area. Detailed information about this *Area* is available at https://www.nyserda.ny.gov/All-Programs/Programs/Offshore-Wind and will be included in the forthcoming NYS Offshore Wind Master Plan. NYS has asked BOEM to identify and lease at least four new Wind Energy Areas (WEAs) within the *Area*, each capable of generating at least 800 megawatts, as part of its upcoming Call. Task Force member questions and remarks focused on (1) the need for better data overlays to identify conflicting uses within the proposed *Area*, (2) interest in better understanding NYS efforts to coordinate with other states in the region, and (3) clarification on whether BOEM would require mitigation plans in future leases.

Public Input Opportunities

Below is a summary of public questions and feedback offered during two public input sessions. The summary represents categories of individual remarks only.

- <u>Task Force representation</u> Interest in stronger Task Force representation from the Fisheries Management Councils, impacted stakeholder groups (e.g. recreational ocean users), and other necessary voices (e.g. health and safety experts).
- <u>Conflicting uses</u> Interest in better understanding how BOEM and NYS weigh conflicting uses (e.g. fisheries, navigation) when identifying new WEAs, with several speakers suggesting fishing impacts are not being adequately considered and necessitate a discussion about mitigation.
- <u>Data standards and availability</u> Voicing concern with the data standards BOEM and NYS use when evaluating different phases of leasing and development. There was also interest in exploring opportunities to make data from lessee-funded surveys available for research purposes.
- <u>Promise of wind energy</u> Voicing support for scaling up development of clean energy sources like offshore wind but making sure development is done responsibly.
- <u>Cumulative impacts</u> Interest in better understanding whether, how, and when BOEM assesses the cumulative impacts of offshore wind development when reviewing Site Assessment Plans (SAPs) and COPs.
- <u>Stakeholder outreach</u> Emphasizing the need for BOEM and their lessees to reach out to stakeholders early in the process, particularly those who may have expertise to contribute or felt left out of past discussions.
