

FINAL NOTICE OF OCS SALE 172 Central Gulf of Mexico March 17, 1999

Attached is the Final Notice of OCS Sale (FNOS) 172, Central Gulf of Mexico, to be held on March 17, 1999, in New Orleans.

All of the terms and conditions for Sale 172 are the same as for the most recent Central Gulf of Mexico Sale (Sale 169), **except** for the minimum bid for blocks in water depths of 800 meters or deeper, and a revised Stipulation 4: Blocks South of Baldwin County, Alabama (see below).

NOTICE:

<u>Potential Standard Lease Form Revision</u>. The MMS is considering making revisions in the standard lease form (Form MMS-2005 (March 1986) as amended). The revisions under consideration include shortening the lease form, use of plain English, and clarifying terms of the lease. However, a final decision on revisions to the lease form has not been made and thus the current form will be used for Sale 172.

Blocks Available for Leasing in Gulf of Mexico OCS Oil and Gas Lease Sale 172. [NEW document] All the blocks and partial blocks available for leasing are included in this document. Also included, for each available block, is the available Federal acreage, the minimum bid per acre, and the minimum bid for the block. This is a new document and replaces the Leased Lands List which has been included in the Sale Notice Package in the past.

<u>Minimum Bid</u>. Bidders should note that the minimum bid on blocks in water depths of 800 meters or deeper has been changed to \$37.50 per acre or portion thereof. The minimum bid for all other blocks remains at \$25.00 per acre.

<u>Electronic Funds Transfer (EFT) payments for the 1/5th bonus</u>. The MMS continues to encourage the expanded <u>optional</u> use of EFT for payment of the 1/5th bonus bid. Some bidders will qualify to use EFT securing such payment with only the bid form; others desiring to use EFT will be required to secure the EFT payment by any one of three methods. It is emphasized that bidders may continue to submit a check for the 1/5th bonus with each bid. See "Instructions for Making EFT 1/5th Bonus Payments" included in this package. <u>Unleased Blocks Offshore Baldwin County, Alabama</u>. Potential bidders are advised that a stipulation will be included in any lease resulting on Mobile Area Blocks 829, 957, 958, and 1001. This stipulation has been revised since the publication of the Proposed Notice of Sale. See Stipulation 4 in the Lease Stipulations document and paragraph (u) of the Information to Lessees document included in this package.

<u>Tracts beyond U.S. Exclusive Economic Zone</u>. Tracts beyond the U.S. Exclusive Economic Zone (tracts in the Northern Portion of the Western Gap and in the Northern Portion of the Eastern Gap) are **NOT** offered for leasing in this sale.

Geophysical Information. Submission of a statement at the time of bid submission regarding certain geophysical information is no longer required. See paragraph (k) of the Information to Lessees document included in this package.

<u>Bid Adequacy</u>. High bids are evaluated in accordance with MMS bid adequacy procedures, which have recently been revised (64 FR 6677 of February 10, 1999, included in this Sale Notice Package). A copy of the current procedures ("Summary of Procedures for Determining Bid Adequacy at Offshore Oil and Gas Lease Sales: Effective March 1999, with Sale 172") is available from the MMS Gulf of Mexico Regional Office Public Information Unit.

Notice of Bidding Systems. At least 30 days before any lease sale, a Notice of Bidding Systems is submitted to the Congress and published in the Federal Register; the Notice for this sale was published on the same day as the FNOS. It continues the use of the cash bonus bid with a fixed royalty rate system used since 1978. Furthermore, this Notice of Bidding Systems for Sale 172 will apply to all future sales, until and unless notice is given that an alternative system will be adopted.
