

# Central Gulf of Mexico March 15, 2000

Attached is the Final Notice of OCS Sale (FNOS) 175, Central Gulf of Mexico, to be held on March 15, 2000, in New Orleans.

All of the terms and conditions for Sale 175 are the same as for the most recent Central Gulf of Mexico Sale (Sale 172), **except** that the MMS now requires the use of Electronic Funds Transfer (EFT) for the payment of the 1/5th bonus deposit (see below).

# **NOTICE:**

<u>Electronic Funds Transfer (EFT) payments for the 1/5th bonus</u>. The MMS now requires the use of EFT for payment of the 1/5th bonus deposit. Current OCS lessees and operators may secure such payment using only a signed bid form; others will be required to secure the EFT payment by any one of four additional methods. Procedures for the use of EFT are included in this Sale Notice Package and are available on our Homepage or from our Public Information Unit (see below). <u>Unleased blocks offshore Baldwin County, Alabama</u>. Potential bidders are advised that a stipulation will be included in any lease resulting on Mobile Area Blocks 829, 957, 958, and 1001. Furthermore, the MMS will consult with the State regarding placement of structures in this area. See Stipulation 4 in the Lease Stipulations document and paragraph (u) of the Information to Lessees document included in this package.

<u>Tracts beyond U.S. Exclusive Economic Zone</u>. Tracts beyond the U.S. Exclusive Economic Zone (tracts in the Northern Portion of the Western Gap and in the Northern Portion of the Eastern Gap) are **NOT** offered for leasing in this sale.

<u>Administrative Appeals Withdrawn</u>. The administrative appeals relating to the termination of the leases on the following blocks have been withdrawn. These blocks <u>ARE</u> available for bid in Sale 175:

West Cameron Area Blocks 252 and 253

West Cameron Area, West Addition, Block 405

Main Pass Area, South and East Addition, Blocks 291 and 293

Leasing Maps and Official Protraction Diagrams (OPDs). Bidders should note the publication in the January 13, 2000, Federal Register (65 FR 2191) of a notice regarding the status of outer continental shelf leasing maps and OPDs. The notice lists all of the Gulf of Mexico Region's leasing maps and OPDs and the dates of last revision. These maps and OPDs are currently available through our Public Information Unit at \$2.00 each (the Louisiana and Texas maps are no longer sold as sets). Also available is a CD-ROM (at \$15.00) of all the maps and OPDs of the Gulf of Mexico that are in digital format as listed in the Federal Register notice (in the Central Gulf only NG15-09 is not available in digital format). Note also that area NG16-07 has been named Lund South.

**NOTE**: The CD-ROM contains the maps and OPDs in .pdf format (for viewing and printing in Adobe Acrobat Reader, which is also on the CD) as well as in .gra format (for use in ARC/INFO).

The digital maps and OPDs are also available on our web site in both formats.
