#### Bid Form:

1. Company name as shown on file with MMS, Gulf of Mexico (GOM) company number, company address, map name, map number, and block number must appear on all bids.

2. A statement acknowledging that the bidder(s) understand that they are legally required to comply with all applicable regulations and to pay one-fifth of the bonus bid amount on all high bids **must** be included on the bid form.

3. Amount Bid must be in a whole dollar figure.

4. Amount Per Acre is not required. The MMS will calculate the per acre amount for all official reports based upon official leasing map or protraction diagram acreage.

5. Proportional interest of joint bids must not exceed five decimal places; total interest must always equal 100 percent. There is no limit to the number of joint bidders participating.

6. Type authorized signer's name and title (if applicable) under signature. Each joint bidder must also sign. The typed name and signature must agree exactly. The **name and title (if applicable) must agree exactly** with the name and title (if applicable) on file in the MMS Gulf of Mexico OCS Region Adjudication Unit.
