




Atlantic OCS Renewable Energy Leases



- Seven competitive lease sales
- Generated over \$68 million in high bids for almost 1.4 million acres in federal waters
- 12 (soon to be 13) leases, over 15 GW capacity or 5 million homes powered
- Recent competitive lease, won by Avangrid, was for Wind Energy Area offshore Kitty Hawk, NC
- Once Avangrid's provisional lease has been executed, there will be offshore wind energy leases off every state from Massachusetts to North Carolina (Cape Cod to Cape Hatteras).

Rhode Island / Massachusetts Lease Areas




Deepwater Wind New England LLC

- SAP decision for meteorological buoy expected this year
- COP Survey Plan submitted
 March 2017
- 90 MW South Fork project, expecting a COP by the *end of 2018*



OCS-A 0487 (67,252 acres)


- No Site Assessment Activities Planned
- SAP term began July 2014
- COP due January 2019



Narragansett Electric Company (TNEC)

Right-of-Way (ROW) Grant OCS-A 0506 (9 Statute Miles)

- GAP Approved *December 2014*
- Assigned from Deepwater Wind
 January 2015
- Facility Design Report & Fabrication and Installation Report reviews completed May 2016
- Cable installation completed *November 2016*






Leases Overview | Massachusetts

Bay State Wind

OCS-A 0500 (187,523 acres)

- Conducting cable route surveys (Summer 2017)
- SAP deemed complete and sufficient, conducting environmental and technical review




Offshore MW (Vineyard Wind)



OCS-A 0501 (166,886 acres)

- SAP submitted to BOEM March 31, 2017
- Summer cable route survey activity anticipated



Cape Wind

OCS-A 0501 (166,886 acres)


- U.S. Court of Appeals ordered BOEM to supplement Final Environmental Impact Statement (EIS) with sufficient seafloor data, issued July 5, 2016
- Supplemental EIS 45-day comment period ended May 15, 2017
- BOEM reviewing public comments, will revise SEIS as necessary; final SEIS likely this summer





Unsolicited Lease Requests

- Lease Areas OCS-A 0502 and 0503 went unsold during the 2015 Lease Sale
- On *December 16, 2016* and *January 4, 2017*, Statoil Wind US LLC and PNE Wind USA, Inc., individually submitted unsolicited lease requests for previously unleased areas in the wind energy area offshore Massachusetts.
- **Competitive interest** and BOEM will initiate the competitive leasing process.




Unsolicited Lease Requests

OCS-A 0502 - Details


- 248,015 acres
- 36 whole and 19 partial OCS blocks
- 17 and 42 nautical miles from shore
- 37 and 64 meters deep

OCS-A 0503 - Details

- 140,554 acres
- 19 whole and 9 partial OCS blocks
- 24 and 43 nautical miles from shore
- 32 and 64 meters deep
