



## Auction Process Milestones



## Auction Format Bidding

Bidding occurs over the course of multiple rounds. During each round, BOEM's asking price is raised, and a bidder indicates whether she would be willing to pay that amount for the lease area. When only one bidder is willing to pay that round price, or has the highest exit bid, that bidder wins the auction.

# AVANGRID RENEWABLES



Execute lease October 10, 2017

#### Effective Date: November 1, 2017



## Next Steps Specified in Addendum B, and at 30 CFR 585.235



### 12 months - Preliminary Term

Each lease includes a preliminary term of 12 months (from the lease effective date) in which the lessee must submit a Site Assessment Plan (SAP) to BOEM..



## 4.5 years - Site Assessment Term

Upon approval of the SAP, the lessee will have up to 4 ½ years in which to submit a Construction and Operations Plan (COP) to BOEM.



## 25 year – Operations Term

Upon approval of the COP, the lessee will have up to 25 years to construct and operate their proposed wind facility.
