#### 2016 Department of Interior Tribal Consultation Annual Report

The annual report is a summary of BOEM consultations during one fiscal year. The information in the Annual Report is a summary and was compiled from all of the information captured during the FY 2016 fiscal year.

### I. Summarize and list all of the consultation topics.

BOEM reaches out to federally recognized tribes that have a connection to a proposed BOEM action. BOEM conducts consultation with those tribes through a variety of approaches, depending on the scope, scale and significance of an undertaking. This could include face-to-face, government-to-government meetings for complex, controversial, or large scale actions; other approaches include letters sent by certified mail, followed up with phone calls and emails. BOEM tribal liaisons also answer questions and requests for information from tribal staff as requested on a case by case basis.

**Headquarters:** The BOEM Headquarters did not conduct any formal government-to-government consultations during FY 2016, but did targeted outreach to federally recognized Tribes along the Atlantic Coast in the proposed program areas for the below actions.

## 4. Summarize and list all of the issues and recommendations. Headquarters:

The most common recommendation during the 2017-2022 BOEM Five-Year Program development
was for Native Village meetings to be scheduled with the Spring Hunt (a sacred cultural practice) in
mind. BOEM strictly adheres to this but changed meeting times and dates multiple times during the
process, which affects the positive relationship the BOEM Alaska Region has with these
communities.

## Alaska Region:

- With respect for of the very large public documents: a) 2017–2022 BOEM Five-Year Program; and, b) Proposed Lease Sale 244 in Cook Inlet very helpful read-ahead summaries were developed and provided for the public. Significant outreach efforts were made to get them into the hands of scientists, tribal and community leaders, and the general public well in advance of related public meetings. The results were fully positive and encouraging a new 'best practice' is now in use. These 11-to-13 page documents can be found online at the BOEM website. Further, as was noted by everyone who has taken the opportunity to read and review, each Summary is filled with practical language and useful visuals.
- The consultation on the proposed air quality rulemaking with the ASRC involved three separate meetings with detailed discussion of issues and exchange of letters.
- Some combination of appointed note-takers, or court reporter(s) was responsible for recording our public meetings. The court reporters, the 'official testimonies' were recorded and either are, or will be, available on BOEM's website.
- With respect to consultations in and of themselves, consultations are held between to sovereigns (the United States, and the Federally-recognized Tribe, or ANCSA Corporation). Records are shared only between and among the consulting parties and are, by definition, not public.
- BOEM Alaska Region continues to place an obvious high value on the obtaining and use of traditional / indigenous knowledge for studies, research, and notably decision-making considerations.
- Further, the Region has stepped up efforts to 'return and report' to communities about the uses and applications of traditional / indigenous knowledge identifying the power and value of such input.
- Worthy of mentioning . . . separately, from the aforementioned listings included in this draft input (for the BOEM Report) are several Alaska Region outreach efforts to establish internship opportunities through partnering with the Alaska Native Science and Engineering Program (ANSEP) of the University of Alaska Anchorage. This project has many parts and pieces to it. Once it is successfully developed it may become a pathway forward that others may desire and choose to follow for Federal employment.

**Pacific Region:** During meetings with Chumash community leaders in support of the BOEM study, Archaeological and Biological Assessment of Submerged Landforms off the Pacific Coast:

- Concerns were raised over the proposed limited collection of targeted sediment samples during this project. Because of these concerns, the BOEM Pacific Region prepared a Finding of No Historic Properties Affected (Findings Document) of the proposed undertaking under Section 106 of the National Historic Preservation Act. This letter was sent to Chumash community leaders, the Advisory Council on Historic Preservation, and the California State Historic Preservation Office (CA SHPO), among others. In October 2016, the CA SHPO issued a letter of concurrence with the Findings Document.
- A Native American internship was created to provide up to two student interns an opportunity
  to spend up to two days each on the research vessel that conducted the geophysical surveys
  around the Northern Channel Islands. One student intern from the Santa Ynez Band of Mission
  Indians participated in this survey.

# 5. Summarize successes and accomplishments and include recommendations for improvements to the consultation process.

- The Tribal Liaison Representatives who contributed to this Report are finalizing the first draft of a BOEM Consultation Recommended Practices policy document, which has been released to supervisors as part of the approval process. The purpose of this document is to help those who have decision making authority at the national and regional level understand their trust responsibility under Executive Order 13175 and the Department's Policies for engaging in tribal consultation (S.O. 3317; DM 512 Chapters 4 & 5). BOEM strives to ensure consistent and meaningful consultation across Regions and Program Offices.
- BOEM Tribal Liaison Representatives have recommended to management that they meet annually to exchange knowledge, plan goal implementation, and receive training in their field.
   An Atlantic and Gulf BOEM Outreach Plan has been drafted in order for BOEM to get better acquainted with the federally recognized Tribes in these areas.
- In November 2015, the BOEM Pacific Region released 'A Guidance Document for Characterizing Tribal Cultural Landscapes' (OCS Study BOEM 2015-047). This document presents a method for agencies to consult with tribes more effectively and appropriately in advance of any proposed undertakings. The document was developed by a team that included representatives from BOEM and the National Oceanic and Atmospheric Administration, as well representatives from the Tribal Historic Preservation Offices of the Makah Tribe of Washington, the Confederated Tribes of Grande Ronde of Oregon, and the Yurok Tribe of California. - The BOEM Alaska Region expanded its efforts to increase the number of ANCSA Corporations –
  both Regional and Village that may wish to more fully participate and engage with the agency.
  The Region has been actively developing several levels of new tribal relations training that have
  potential transportability. BOEM's Tribal Relations Working Group (the Tribal Liaison
  Representatives for each region and the headquarters) are engaged with further developing
  such training courses and usefully unpacking recent tribal related directives.
