Proposed Revision of BOEM EIS- and ROD-Related Delegations to Align With

New DOI Deputy Secretary NEPA Streamlining Directive

I recommend revising five BOEM Environmental Impact Statement (EIS) and Record of Decision (ROD) delegations in BOEM Manual Chapter 218.2:

- Delegation 1.27 Approve/Sign/Issue a Federal Register Notice required by NEPA;
- Delegation 1.28 Approve for publication a Delegated Lease Sale EIS;
- Delegation 1.29 Approve or sign a ROD related to a Delegated EIS, except for Lease Sale EIS:
- Delegation 2.119 Make a determination to prepare any Delegated EIS (including Lease Sale and Programmatic EISs); and,
- Delegation 2.120 Approve for publication any other Delegated EIS, except a Lease Sale

The proposed revisions would align, to the maximum extent allowed by regulation, the Delegations of Authority with guidance provided in the April 27, 2018, Department of the Interior (DOI) Deputy Secretary Memorandum entitled, NEPA Document Clearance Process, which gives directions regarding the role of the first Senior Executive Service (SES) member with line authority over the proposed action for which BOEM is preparing an EIS for approval and other related decisions (first-line SES member) (April 27, 2018, memorandum). Once implemented, these changes would help streamline the approval process for NEPA documents and increase the efficiency, consistency, and clarity in EIS processing and BOEM decisionmaking. These recommendations were coordinated with the BOEM Program Chiefs and Regional Directors. These delegation changes would not divest the Director of any concurrent authority to approve/sign/issue any notice or decision, if circumstances warrant it.

Delegation 1.27 - Approve/Sign/Issue a Federal Register Notice required by NEPA

The current Delegation of Authority to approve, sign, or issue a Federal Register Notice is the BOEM Director. The proposed revision would also delegate the authority to take these actions to the first-line SES member (the Chief Environmental Officer [CEO], or the Office of Strategic Resources [OSR] Chief, when designated, or the Regional Director [RD], for Region-specific actions or decisions). The revision would align this delegation with the process outlined in the April 27, 2018, memorandum.

Delegation 1.28 - Approve for publication a Delegated Lease Sale EIS

Under the current Delegations of Authority, a decision to approve a lease sale EIS for publication is delegated to the BOEM Director. We propose also to delegate the authority to make this type of decision to the first-line SES member (the CEO or OSR Chief, when designated, or RD, for Region-specific actions or decisions). This change would align the Delegation of Authority with the process outlined in the April 27, 2018, memorandum. The CEO, OSR Chief, or RD would be responsible for navigating the DOI Review Team process and ultimately approving EISs following completion of that process. The Assistant Secretary, Land and Minerals Management (ASLM), would still make lease sale related decisions. The ASLM would sign the Record of Decision and all other OCSLA documents according to other existing lease sale delegations.

$\frac{Delegation~1.29-Approve/Sign~a~ROD~related~to~a~Delegated~EIS,~except~for~Lease~Sale}{EIS}$

The current Delegation of Authority to approve or sign a ROD related to an EIS is the BOEM Director. The proposed revision would also delegate this authority to the official designated in BOEM Handbook 210.H, or in an individual delegation memorandum signed by the Director, to approve the BOEM decision, which the Delegated EIS informs. In the event the approval authority was not re-delegated, it would continue to be delegated to the Director. The revision would align this Delegation of Authority with the process outlined in the April 27, 2018, memorandum in a manner fully consistent with the definition of "responsible official" in Interior's NEPA regulations and the Council of Environmental Quality's regulations regarding RODs.

<u>Delegation 2.119</u> - Make a determination to prepare a Delegated EIS (including Lease Sale and Programmatic EISs) and Delegation 2.120 - Approve for publication a Delegated EIS, except a Lease Sale EIS

The current Delegation of Authority for both of these decisions is the CEO and RD; the proposed revision would also delegate this to the first-line SES member (either the CEO or OSR Chief, where designated, or the RD, for Region-specific decisions). This change is critical because it eliminates a situation where two individuals are making one decision, as seen in the current process. This change would align these Delegations of Authority with the process outlined in the April 27, 2018, memorandum. The CEO, OSR Chief, or RD will be responsible for navigating the DOI Review Team process and ultimately approving EISs following completion of that process.

Path Forward

I recommend that you approve the proposed changes to the BOEM Delegations of Authority. In accordance with the procedures for changing BOEM Program Delegations, outlined in BOEM 218.2 Program Delegations Handbook, we are providing a BOEM Form 5100 for each of the proposed changes described above.
