## **BOEM Proposes Oil and Gas Lease Sale in the Gulf of America**

**06/25/2025**

WASHINGTON – The Bureau of Ocean Energy Management today announced the publication of a Proposed Notice of Sale (PNOS) for an oil and gas lease sale in the Gulf of America.

As directed by Secretary of the Interior and outlined in the PNOS, Lease Sale 262 will offer approximately 15,000 unleased blocks located 3 to 231 miles offshore across the Gulf's Western, Central, and Eastern Planning Areas. Covering roughly 80 million acres, these blocks are situated in water depths ranging from 9 feet to more than 11,100 feet (3 to 3,400 meters).

### **INFORMATION TO LESSEES**

**LEASE EXTENSION REQUESTS:** To earn the extension of the initial period, all requests should be submitted from the **Lessee** and not the **Operator**. Please refer the Lease Addendum attached with the subject lease documents. The request should be submitted as soon as practicable, but in no case more than 30 days after spudding a well. The BOEM New Orleans Regional Supervisor for Leasing and Plans will confirm in writing, within 30 days of receiving the **Lessee's** letter, whether the **Lessee** has earned the extension of the initial period and update BOEM records accordingly. The extension of the initial period is not effective unless and until the **Lessee** receives confirmation from BOEM.

### **Leasing and Plans Important Notice**

To process filings as expeditiously as possible, you should submit all documents to the Office of Leasing and Plans (OLP) via email whenever possible.

OLP staff will be available to assist you through email or Microsoft Teams calls. You may submit filings to the sections in OLP as follows:

**Adjudication Section** – Filings must be submitted either via postal mail, courier service or electronic mail. In-person, hand filings will not be accepted. Electronic submissions must be in PDF format and emailed to the Adjudication Section mailbox at [boemadjudication@boem.gov](mailto:boemadjudication@boem.gov). All questions related to actions processed by the Adjudication Section should also be directed to the Adjudication mailbox.

### **Leasing and Financial Responsibility Section (LFRS) –**

**Financial Assurance** – All filings must be submitted via postal mail, courier service or electronic mail. Electronic submissions must be in PDF format and emailed to the financial assurance mailbox at [boemgulffinancialassurance@boem.gov](mailto:boemgulffinancialassurance@boem.gov).
