## Office of Primary Responsibility: Office of Budget and Administration

- 1. **Purpose**. The purpose of this Interim Policy Document (IPD) is to provide redelegations of certain administrative authorities in Bureau of Ocean Energy (BOEM) Manual (BOEMM) 218.1-H, "Administrative Delegations of Authority Handbook," from the Deputy Director to the Associate Director, Office of Budget and Administration (OBA), unless otherwise noted.
- 2. **Scope**. This IPD applies to all BOEM employees responsible for obtaining approval or concurrence for administrative functions.
- 3. **Objective**. The administrative authorities redelegated by this IPD allow for continued efficient administrative operation of the bureau.
- 4. **Authority**.
  - A. 200 Departmental Manual (DM) 1-3, "General Provisions."
  - B. 218 DM 2, "General Administrative Delegation."
- 5. Reference.

- 6. **Policy**. 218 DM 2 delegates specific administrative authorities to the BOEM Director. BOEMM 218.1-H lists certain administrative authorities retained by the Director and administrative authorities redelegated to the Deputy Director. Authorities include approving, concurring, proposing, and signing. This IPD further redelegates administrative authorities of the Deputy Director listed in BOEMM 218.1-H to the Associate Director, OBA, <u>unless otherwise</u> noted in the table below as retained by the Deputy Director or redelegated to another official.
