### **BOEM Announces Next Steps for Gulf of Mexico Oil and Gas Leasing Program December 6, 2024**

#### **Seeks Public Comments on Draft Programmatic Environmental Impact Statement**

**NEW ORLEANS** – Today, the Bureau of Ocean Energy Management (BOEM) announced the availability of the Gulf of Mexico (GOM) Regional Outer Continental Shelf (OCS) Oil and Gas Lease Sales Draft Programmatic Environmental Impact Statement (EIS).

In December 2023, the Department of the Interior published the [2024-2029 National Outer Continental Shelf Oil and Gas Leasing Program](#), which includes three oil and gas lease sales in the GOM over the next five years. The Program balances the nation's energy security and climate goals while also identifying the fewest oil and gas lease sales for a five-year program in history. The Program does not include any lease sales in Atlantic, Pacific and Alaskan waters. The Inflation Reduction Act prohibits BOEM from issuing a lease for offshore wind development unless the agency has offered at least 60 million acres for oil and gas leasing on the OCS in the previous year. This significantly reduced number of oil and gas lease sales from past Leasing Programs will enable the United States to meet its energy needs and continue the rapid and accelerating transition to clean energy. ## **BOEM Updates Service Fee Schedule**

BOEM's regulations, as outlined in 30 CFR § 550.125 and 30 CFR § 556.106, provide the authority for BOEM to periodically adjust certain fees for services.

BOEM is adjusting its service fees for processing documents related to oil and gas activities on the Outer Continental Shelf to reflect inflation since the last update in 2022.

## **Interior Department Takes Action to Protect Taxpayers from Offshore Oil and Gas Decommissioning Costs**

On April 15, 2024, the Department of Interior [announced](#) a final rule from the Bureau of Ocean Energy Management (BOEM) to protect taxpayers from covering costs that should be borne by the oil and gas industry when offshore platforms require decommissioning. The action updated 20-year-old regulations. BOEM has substantially strengthened financial assurance requirements for the offshore oil and gas industry operating on the U.S. Outer Continental Shelf (OCS).

This notice makes a technical correction to the [final rule](#) titled, Risk Management and Financial Assurance for OCS Lease and Grant Obligations, which the Department of the Interior published in the Federal Register on April 24, 2024. The correction clarifies that the effective date of the rule is June 29, 2024.

The Congressional Review Act requires that the effective date of a major rule be 60 days after the date of publication in the Federal Register or receipt of the rule by Congress, whichever is later. The rule was published on April 24, 2024. The rule was received by both chambers of Congress on April 29, 2024, making the effective date June 29, 2024, instead of June 24, 2024.

**LEASE EXTENSION REQUESTS:** To earn the extension of the initial period, all requests should be submitted from the **Lessee** and not the **Operator**. Please refer the Lease Addendum attached with the subject lease documents. The request should be submitted as soon as practicable, but in no case more than 30 days after spudding a well. The BOEM GOM Regional Supervisor for Leasing and Plans will confirm in writing, within 30 days of receiving the **Lessee's** letter, whether the **Lessee** has earned the extension of the initial period and update BOEM records accordingly. The extension of the initial period is not effective unless and until the **Lessee** receives confirmation from BOEM.
