




Renewable Energy Process: From RFI/Call to Operation


Planning and Analysis: Winnowing Process
























































New York Bight Auction: \$4.37 Billion!

Lease stipulation requires lessees to:

- Identify Tribes, ocean users, underserved
 communities, and other stakeholders potentially affected
- Submit semi-annual report on engagement activities, challenges, impacts, and project changes
- Improve lessee communication and transparency
- Encourage engagement with underserved and environmental justice communities



New Lease Stipulations: Project Labor Agreements

 The Lessee must make every reasonable effort to enter a Project Labor Agreement(s) (PLA) covering the construction stage of any project proposed for the leased area.





New Lease Stipulations: Supply Chain


- Requirement to establish a statement of goals that describe plans for contributing to the creation of a robust and resilient U.S.-based offshore wind supply chain.
- 2. Operating fee credit to incentivize the procurement of offshore wind components in the U.S.
