### Meeting Objectives

- Identify priorities, needs, and issues to address through BOEM's draft New York Bight (NYB) Programmatic Environmental Impact Statement (PEIS) specific to environmental justice, underserved communities, and Indigenous Peoples.
- Continue to develop a shared understanding of challenges affecting and efforts to engage environmental justice populations, underserved communities, and Indigenous Peoples on offshore wind issues across New York and New Jersey.
- Provide updates on how previous input is being processed for consideration in BOEM's and others' decision-making processes so far and invite feedback to continue refining next steps.
- Grow relationships and improve coordination across agencies, governments, lessees, Indigenous Peoples, and community-based organizations.

BOEM will provide an overview of the Input Status Report developed following the October 2022 EJF, and a more detailed presentation on three topic areas to show how the potential impact is analyzed in the PEIS and/or how it's treated in the Input Status Report.

- Air quality
- Indigenous Peoples outreach and engagement
- Capacity building and compensation mechanisms pathways
- 5. Continued Discussion of Potential Impacts and Mitigation Measures (30 minutes, or with the time remaining after concluding the previous discussion)

Reflect on whether there are themes that are not reflected in the Input Status Report. Breakout rooms to discuss:

- Are there local and regional issues that are not identified in the Input Status Report on how the PEIS approaches community identification and characterization, related to:
  - o Important coastal areas to you or the communities you serve?
  - Existing environmental stressors in your area?

- What are draft mitigation measures that should be analyzed in the PEIS?
- Are there other potential impacts of offshore wind activities, including both benefits and burdens to environmental justice populations, to raise?
