

# INTERGOVERNMENTAL RENEWABLE ENERGY TASK FORCE FOR THE GULF OF MAINE DECEMBER 12, 2019 MEETING SUMMARY

DISCLAIMER: This meeting summary was prepared by the Consensus Building Institute (CBI), a non-profit entity contracted by BOEM to facilitate Task Force discussions and draft a discussion summary. This summary is not intended to be a meeting transcript. Rather, it focuses on the main points covered during the meeting.

#### **MEETING IN BRIEF**

This initial meeting of the Intergovernmental Renewable Energy Task Force for the Gulf of Maine was convened to facilitate coordination and consultation among federal, state, local, and tribal governments by introducing their respective roles and responsibilities regarding offshore wind energy and the renewable energy leasing process. The meeting also sought to update participants on recent activities in New Hampshire, Maine, and Massachusetts related to offshore wind, as well as provide opportunities for public input.

The meeting opened with introductory remarks from the Bureau of Ocean Energy Management (BOEM) and NH Governor Sununu. Presentations during the day described the offshore leasing process, the roles of different governmental bodies, initiatives underway at the state level, and sources of information and relevant research.

In small groups, Task Force members discussed the best way to initiate the offshore leasing process, the role of the Task Force in that process, and other considerations. All members of the public who wished to comment had a chance to do so during sessions in the morning and afternoon. #### ATTENDANCE

Seventy-six Task Force members attended the meeting. In addition, 174 members of the public attended, including representatives from the commercial fishing industry, wind energy developers, academic researchers, and interested citizens.

#### **DISCUSSION**

Below is a summary of key themes and topics discussed during the meeting.

#### **Welcoming Remarks**

James Bennett, Chief, BOEM Office of Renewable Energy Programs (OREP), and Governor Sununu opened the meeting, encouraging stakeholders to view offshore wind development as a "team effort" that won't be successful unless the process listens to all people who might feel impacted by it.

## Morning presentations - The BOEM leasing process and state-level initiatives

James Bennett, Luke Feinberg, and Meredith Lilley from BOEM described BOEM's leasing process and how it might move forward in the Gulf of Maine. Then, Maine, New Hampshire, and Massachusetts presented on state initiatives related to renewable energy and offshore wind. Task Force comments and questions included:

• Timelines for leaseholders; the role of leaseholders in transmission as well as generation; the possibility of offshore transmission networks; decommissioning of infrastructure; and aesthetic considerations



- Coordination between state regulatory processes and the BOEM process
- Workforce development in the region

Comments and questions from other attendees included:

- Voices of support to act rapidly on wind development to address climate change
- Opportunity for the region to be a leader in floating technology
- Concerns from commercial fishermen about the impacts, and a desire to be involved in the process
- Interest in maximizing local jobs

## Afternoon presentations - Jurisdictional Authorities and Information Resources

The afternoon included short presentations from: United States Coast Guard; NOAA National Marine Fisheries Service; NOAA National Ocean Service; OceanReports and Northeast Regional Ocean Portal; Northeast Regional Ocean Council; New England Fisheries Management Council; Responsible Offshore Development Alliance; U.S. Department of Energy; BOEM's Environmental Studies Program. Task Force members had questions and comments in reaction to these presentations, including:

- We should be learning more from the experience in Europe, including the experience of fishermen.
- We should fund a local university to look at best practices with floating platforms to see how to reduce impacts on fishing.

## **Small group conversation – summary ideas**

Below are some of the main ideas that emerged from the small group conversations among Task Force members.

## Where do we start?

- Move efficiently. Start with a Planning Area or Request for Interest with qualifications (red-line areas).
- Be inclusive and comprehensive, yet as quick as possible.
- Get input from key stakeholders such as commercial fisherman as soon as possible.
- The states lead the way.
- The next meeting should include an update on the technology.

# What areas of concern have we not talked about yet?

Navigation, shipping lanes total footprint; fishing logging data; access to ports and construction, interconnection points; regional power needs and transmission planning; shared transmission offshore; supply chain opportunities; economic benefits of developing projects; renewable energy credits; technical challenges to deeper water (gaps in data); right whales and floating cables; details of participatory process and how to engage locally; learning from other countries; primer on energy and floating technology; tribal stakeholder engagement; aesthetics/viewshed; technology of fishing and adaptability to wind infrastructure

# What is most important in this process?

- Inclusive, participatory, good communication – Have digestible information for local/state reps/officials to bring to constituents. Feedback is looped back in.
- Learn from the experience further south (and Europe) – document lessons learned
- Need for urgency and an endpoint
- Acknowledge differences between the states, their history

## Conclusion

The meeting ended with an open dialogue with all participants and Task Force members, in which similar themes emerged regarding the importance of moving quickly, concerns about impacts on fishing, a desire to coordinate participation among stakeholders, and gratitude for the way this meeting was handled. BOEM concluded by thanking all participants for their input.
