





Density Analysis



- Kitty Hawk submitted their COP in December 2020
- COP is currently available at: www.boem.gov/kitty-hawk
- BOEM can approve, disapprove, or approve with conditions
 - Will happen after environmental impact statement (EIS) is complete and will be documented by the Record of Decision (ROD)
