### **Executive Summary**

This Progress Report is prepared in accordance with Invenergy California Offshore LLC's (Invenergy; Lessee) Commercial Lease OCS-P 0565 (Lease), which requires that Invenergy submit a Progress Report to the Bureau of Ocean Energy Management (BOEM) every six months through the Construction and Operations Plan approval process. This Progress Report covers the reporting period from **June 1, 2024, to November 30, 2024.** As required by Addendum C, Section 3.1.1 of the Lease, this Progress Report documents overall project progress and engagement activities undertaken with agencies, Native American Tribes, communities, ocean user groups, and the public over the reporting period, as well as plans for continued engagement.

# **1** Purpose and Background

### 1.1 Purpose

This Progress Report is prepared in accordance with Commercial Lease OCS-P 0565, which requires that Invenergy California Offshore LLC (Invenergy; Lessee) submit a Progress Report to the Bureau of Ocean Energy Management (BOEM) every six months through the Construction and Operations Plan approval process. This Progress Report covers the reporting period from **June 1**, **2024**, **to November 30**, **2024**. As required by Addendum C, Section 3.1.1 of the Lease, this Progress Report documents overall project progress and engagement activities undertaken with agencies, Native American Tribes (Tribes), communities, ocean user groups, and the public over the reporting period as well as plans for continued engagement.

### **1.2 Lessee Information**


Invenergy, a leading, privately held developer, owner, and operator of sustainable energy solutions, is the leaseholder for Commercial Lease OCS-P 0565. Invenergy is an American-led company with over 20 years of experience developing clean energy solutions across the United States and globally. Invenergy has successfully developed over 200 projects worldwide comprising over 32 gigawatts that are in operation, construction, or contract. In addition to the Even Keel Wind (EKW) project (project) discussed in this Progress Report, Invenergy is the lead developer of the Leading Light Wind project located in the New York Bight offshore of New Jersey.

### **1.3 Lease Description**

On June 1, 2023, Invenergy executed an offshore wind lease in the Morro Bay Wind Energy Area. Lease OCS-P 0565 is located more than 20 miles from the closest location onshore and encompasses approximately 80,000 acres of the Outer Continental Shelf. See Figure 1. Invenergy intends to build the EKW project on Lease OCS-P 0565 which will include wind turbine generators and offshore substation(s) as well as export cables connecting to California's onshore electrical grid.

Over the term of the Progress Report, Invenergy has been establishing protocols for offshore and onshore data collection and surveys that will be undertaken to characterize the project site and inform project layout, design, and engineering. Invenergy has also engaged with stakeholders including agencies, Tribes, communities, ocean users, and the public regarding project development. These inputs will support the preparation of a project Construction and Operations Plan that will be submitted to BOEM. Upon receipt of a complete Construction and Operations Plan, BOEM will issue a Notice of Intent to prepare an Environmental Impact Statement, which will initiate the process of analyzing potential impacts of the project and identifying appropriate avoidance, minimization, mitigation, and monitoring measures.

# 2 Tribal Engagement

Invenergy continues engagement with Tribes in accordance with the central coast lessee's Joint Native American Tribes Communications Plan (NATCP), which is included in Appendix C of this Progress Report. Invenergy works collaboratively with the other two central coast lessees (Golden State Wind and Atlas Wind) to reduce the overall communications burden on Tribes. Tribal feedback on this approach has been positive. The Tribal Liaisons for all three companies meet regularly to connect on upcoming activities and stay coordinated.

During this reporting period, the central coast lessees sent the Tribes two quarterly updates that included a summary of joint lessee activities (including a discussion of capacity funds), project-specific updates, helpful links, local perspectives and fact-checking, opportunities for Tribal members in marine monitoring, and general information on metocean buoys. These updates continue to offer meetings between lessees and interested Tribes to discuss project updates or other topics of interest.

Invenergy's direct communications with Tribes during the reporting period were largely focused on capacity building funds, which are intended to cover time, travel, and other expenses incurred by Tribes to engage on the EKW project. Over the next year, Invenergy anticipates holding conversations with Tribes on topics such as survey plans, visual simulations, and resources of concern. These capacity building funds will reimburse Tribes for time spent in meetings (remote and/or in-person), travel expenses



related to meeting attendance, time spent reviewing documents, and expenses related to hiring consultants to assist Tribes. Invenergy began these discussions in May 2024 and has continued engagement throughout the reporting period (Table 1). In parallel, Invenergy and the other central coast lessees continue efforts to identify a nonprofit or foundation that would be able and willing to hold and distribute capacity building funds. While communications continue, no formal agreement has been reached with any Tribes on capacity funding to date.

# 2.1 Overall Tribal Engagement Progress

In addition to Tribal capacity funding, Tribal engagement over the reporting period involved information sharing, project updates, and attendance at Tribal events. Table 1 includes a summary of engagement activities Invenergy conducted with Tribes during the reporting period.

### 2.2 Identification of Potential Project Effects Related to Tribal Interests

As outlined, Invenergy's communications with Tribes during the reporting period were primarily focused on Tribal capacity funding. Specific Tribal input on potential effects and other factors that would influence project design and implementation to date has been minimal. Table 2 includes a high-level summary of issues raised by Tribes during the reporting period.

### 2.3 Tribal Feedback on Transmission Planning

Invenergy has not yet commenced transmission planning for the project. As the development process matures, potential transmission points of interconnection and cable routes will be discussed with Tribes to seek their feedback.

# 3.2 Summary of State Agency Engagement Activities

Regular engagement with state agencies took place over the reporting period focused on relevant offshore wind development topics. For example, engagement with state agencies including California Independent System Operator (CAISO), California Public Utilities Commission (CPUC), and California Energy Commission (CEC) addressed the Assembly Bill 1373 Central Procurement mechanism, transmission planning and interconnection issues, as well as permitting topics. Invenergy maintains open lines of communication with California policy and decision makers in support of offshore wind.

Discussions were also held with multiple agencies and the fishing industry through the California Coastal Commission's (CCC) Offshore Energy and Fisheries Working Group, which is tasked with creating a strategy to ensure that offshore wind projects avoid and minimize impacts on fisheries. This strategy includes best management practices to reduce impacts on fishing activities to support the long-term health and resilience of fisheries. The Working Group also aims to provide fair compensation to commercial and recreational fishing interests, as well as Tribal fisheries, for any economic impacts from offshore wind development. The Working Group is made up of members from commercial and recreational fishing industries, offshore wind companies, state agencies, and federal agencies.

# 3.4 Summary of Fisheries Engagement Activities

Invenergy continued participation in the CCC Offshore Wind Energy and Fisheries Working Group over the reporting period. The CCC Offshore Wind Energy and Fisheries Working Group is tasked with developing strategies to reduce impacts to fishing and fisheries, as described above in Section 3.2. Invenergy participates in multiple subgroups and engages with individual members to advance the goals of the Working Group. These activities are listed above in Table 5 since they are facilitated by the CCC.

Invenergy also continues to participate in both the Pacific Fisheries Management Council and Marine Planning Committee meetings to stay informed on fishing activities, share project updates, and be available for stakeholder questions. In addition, the three Central Coast lessees continue coordinated fisheries engagement activities, when practical, to reduce the overall burden on the fishing community. The Fisheries Liaisons for all three companies meet regularly to connect on upcoming activities and stay coordinated.

Table 7 provides a summary of engagement activities conducted with fisheries interests during the reporting period in addition to the CCC's Offshore Wind Energy and Fisheries Working Group (which are included in Table 5).

# 3.5 Summary of Other Engagement Activities

# 4 Survey Plan Activities Under BOEM Review or Underway

Over the reporting period, Invenergy continued to systematically analyze and query the market to build a robust understanding of floating offshore wind technology's deep-water capabilities, limitations, and areas for further investment and analysis. In parallel, Invenergy continues to assess federal guidance for all types of survey work to understand equipment and techniques that are suited for deep-water application, as well as build an inventory of available in-situ data to create a preliminary ground model that identifies geohazards and resources that warrant further investigation. Our goal is to continue our due diligence to understand deep-water needs and conditions to support the advancement of our engineering assessments and preparatory work for surveys moving into 2025 and beyond.

Invenergy continues to explore means to efficiently collect metocean data for the lease area including purchasing data from buoys deployed by third parties such as TGS<sup>3</sup> and/or deploying buoy(s) within the Lease Area. On September 4, 2024, Invenergy submitted a request to further extend the due date for submittal of a Site Assessment Plan to June 01, 2025, from the original request of September 13, 2024. On September 12, 2024, BOEM granted the extension request and forwarded a letter of approval for the extension to Invenergy. As indicated in Tables 11 and 12, no specific survey plan activities are under BOEM review or underway as work continues on developing an appropriate survey strategy.

# 5 Accessibility

- Posted Spanish language versions of the project factsheet, Agency Communication Plan, and FCP on the EKW project website.
- Posted Spanish language project fact sheet on EKW website.

# 6 Coordinated Engagement

Throughout the reporting period, Invenergy has worked closely with the other California offshore wind lessees on joint advocacy related to emerging legislation, policy, and guidance. In addition, as detailed above, Invenergy and the two other central coast lessees have coordinated efforts on Tribal engagement and fisheries engagement, participated jointly in local community events and agency meetings, and strategized on permitting topics. These collaborative efforts have received compliments from state agencies, Tribes, and stakeholders.

In April of 2024, after many months of joint advocacy, the Northern Chumash Tribal Council and Morro Bay Offshore Wind Lessees announced their joint position in support of a phased approach to the designation of the Chumash Heritage National Marine Sanctuary (CHNMS). In October of 2024, NOAA announced its modified proposal for designation of CHNMS consistent with the joint position. This effort exemplifies the importance and benefit of joint efforts among the Lessees, Tribes, and other stakeholders.

Invenergy is also a member of the ACP's California Council of Offshore Wind Leaseholders (CCOWL), which was established in October 2023. The CCOWL is a coalition of offshore wind lessees dedicated to advancing the development of offshore wind energy projects along California's coast. CCOWL seeks to harness the economic, environmental, and clean energy benefits of offshore wind to help California meet its sustainability and renewable energy goals. The council members are Invenergy, RWE, Atlas Wind, Golden State Wind, and Vineyard Offshore; membership will be open to future lessees going forward. Coordinated by ACP, the CCOWL facilitates collaboration among California lessees and shared advocacy. ACP CCOWL engages with state and federal agencies, the legislature, and stakeholders. These meetings are additive to the engagements undertaken by individual lessees.



As the development process continues, Invenergy will explore additional ways to facilitate coordinated engagement on topics such as research, data collection, project layouts, and monitoring. Information will be shared via future Progress Reports.
