#### 1.0 PURPOSE, REPORTING, AND COMMENTING

#### **1.1 Progress Report Purpose**

TotalEnergies Renewables USA, LLC ("TotalEnergies"), is the leaseholder of Lease Area OCS-A 0545 ("Lease Area"), a 54,937-acre area approximately 20 nautical miles from the coast of North Carolina. TotalEnergies proposes to construct and operate a wind energy generation facility within the Lease Area called TotalEnergies Carolina Long Bay ("TE-CLBay" or "Project").

TotalEnergies has developed this Progress Report ("Report") to comply with lease Addendum C Section 3.1, which requires a progress report every six months (or as Bureau of Ocean Energy Management ["BOEM"] otherwise directs) through the site assessment term that includes a brief narrative of engagement since the last progress report, or, in the case of the first report, since the lease effective date (June 1, 2022).

Due to the early timing of the project and introductory nature of discussions with stakeholders, specific project design elements, transmission planning and implementation strategies were not discussed - and no potential effects were identified. Future Progress Reports will include potential effects that are identified and discussed with interested parties as well as the evaluation of those potential effects.

If BOEM provides comments on the progress report (within 60 calendar days from receipt), TotalEnergies will address comments and modify the progress report.

### **1.2 Potentially Affected Groups**

TotalEnergies engagement efforts are focused on groups that may be potentially affected by the Project. These groups include but are not limited to the following.

#### 1.3 Progress Report Organization

This Progress Report has been developed based on requirements outlined in Section 3.1 of Addendum C of Lease OCS-A 0545 and is organized by two audience-specific sections: Section 2.0, Tribal Engagement and Section 3.0, All Other Potentially Affected Parties Engagement. Per lease stipulation 3.1.4, the progress report must include an update regarding progress in executing the

activities included in survey plans, however TotalEnergies has not completed any survey plans and therefore no update is included within this document.

TotalEnergies and Duke Energy Renewables Wind, LLC (DER), owner of the adjacent Lease Area OCS-A 0546, have agreed to hold joint outreach meetings when possible as the projects advance per lease stipulation 3.1.3.

#### 2.2 Tribes with Interests in the Project

#### 2.3 Tribal Engagement Activities

#### 2.3.1 Summary of Engagement Since the Lease Effective Date

Following lease execution, TotalEnergies, DER and BOEM discussed postponing project-specific outreach to the Tribes until after BOEM's initial outreach would conclude in mid-October 2022. Per these discussions, Total Energies submitted an extension request for obligations relating to engaging with Tribes and those obligations relating to the Native American Tribes Communication Plan (NATCP) as set out in sections 3.1.1 and 3.1.2 of Addendum C of Lease OCS-A 0545 to February 2023. The extension, approved by BOEM on October 21, 2022, allows for alignment of outreach efforts to the Tribes and will form a strong start for continued engagement.

Following BOEM direction, TotalEnergies and DER began engaging with Tribes in November 2022 with the distribution of a Tribal Engagement Survey designed to determine the preferred level of engagement for each Tribe and inform the NATCP.

#### 3.2 Stakeholder and Community Engagement Activities

#### 3.3.1 Summary of Engagement Progress Since Lease Effective Date

Since acquiring the Lease, TotalEnergies has continued to build and expand its stakeholder and community engagement team for the Carolina Long Bay Project, which includes a project director (started in September 2022), a community engagement manager (started in November 2022), and a fisheries liaison (to start January 2023). During this time, TotalEnergies has pursued numerous engagement activities with fishing communities, agencies, and other stakeholders by attending conferences, technical and management meetings, and community events. Through these efforts, TotalEnergies has established relationships with federal and state agencies, members of fishing communities, universities, technical working groups, and members of the public. TotalEnergies continues to build upon and strengthen these relationships by providing Project information and updates and remaining open and flexible to pursuing different avenues for information sharing.
