Subject:	Bureau of Ocean Energy Management (BOEM) Manual Chapter 218.2 Program Delegations and BOEM Program Delegations Handbook 218.2-H

The recent publication of the 218 Departmental Manual (DM) 1 (BOEM-General Program Authority) and 2 (BOEM-General Administrative Delegations) in the Electronic Library of Interior Policies (ELIPS), establishes authorities for BOEM's program and program-related functions. In accordance with the authorities delegated to BOEM, the Office of Policy, Regulation, and Analysis (OPRA) updated and revised the MMS Manual Chapter Offshore Leasing and Operations Special Redelegations, 2009 (Manual Chapter) and the MMS Offshore Program Delegations Handbook 210.1-H. They are ready for your review and approval.

The updated documents reflect appropriate BOEM approval levels for all activities in the current (2009) Manual Chapter and (2009) Handbook, and they reflect the change in the Bureau name and revisions to the organizational and management structure. Additions include: renewable energy program activities (which were previously published in a separate 2009 memo), an expanded list of renewable energy and environmental program activities as requested by BOEM's Office of Renewable Energy Programs and Office of Environmental Programs, a delegated authority for canceling non-producing renewable energy leases, and changes stemming from the AD06 Leasing Rule effective May 31, 2016. These documents reflect input from BOEM Regional Offices and Program Offices, coordination with the Bureau of Safety and Environmental Enforcement (BSEE), and input from the Office of the Solicitor. Coordination of these documents, with BSEE, was conducted in accordance with BOEMM 200.1 on Redelegations and BOEMM 218.2 on BOEM Administrative Delegations of Authority.

The 2017 BOEM Manual Chapter provides the authorities, references, and procedures related to BOEM's program and program-related redelegations. The revised BOEM Handbook provides the authorities, references, and approval levels for program and program-related activities delegated to the BOEM Director. While the Manual Chapter and Handbook provide some cross-references to the 218 DM 1 and 2, the BOEM documents do not list the Secretary's authorities.

OPRA recommends that the Acting Director approve both the updated BOEM Manual Chapter and Handbook. OPRA developed a mechanism to streamline future updates to the Handbook, using a BOEM Form 5100 and process as outlined in the BOEM Delegations of Authority Manual Chapter.

Copies of 218 DM 1 and 2 published by the Department, the new BOEM Form 5100, BOEM Manual Chapter 218.2 Program Delegations and BOEM Program Delegations Handbook 218.2-H, the 2009 MMS Manual Chapter, 2009 MMS Handbook, and the 2009 MMS Renewable Energy delegation memo are attached for background and reference.

With the approval of this Handbook, specific BOEM Program authorities are re-delegated from the Director as shown in Chapter 2. To the extent that this Handbook conflicts with the authorities identified in the DM as being retained at the Department level, the DM controls.

Use the Handbook with the date matching the current calendar year. Also check for program delegation changes approved during the current calendar year, which are listed in the Changed Program Delegations Table on the BOEM website.

A program delegation change is not effective until it is signed by the Director. The process for making those changes is described in BOEMM 218.2, BOEM Program Delegations.

CHAPTER 1 AUTHORITIES DELEGATED TO THE BOEM DIRECTOR

1.1 Authorities Retained at the Departmental Level

Most of the authorities retained at the Department level are listed at 218 Department Manual (DM) 1.4. Authorities related to rulemaking that are retained at the Department level are in 318 DM 1, 2, and 3. The clearance required to print delegated and non-delegated Environmental Impact Statements (EISs)¹ is addressed in the most recent Environmental Statement Memorandum from Willie R. Taylor, Director, Office of Environmental Policy and Compliance, to Heads of Bureaus and Offices regarding Approving and Filing Environmental Impact Statements (ESM 15-2; Sept. 25, 2015), available on the Department's Office of Environmental Policy and Compliance Resources page at <u>https://www.doi.gov/oepc/resources</u>, in the Environmental Memoranda Series.

1.2 Authorities Delegated

The BOEM Director is delegated a portion of the Secretary's and the Assistant Secretary for Land and Minerals Management's (ASLM's) authority for managing and administering the offshore leasing and operations program in 218 DM 1. Delegations for the Bureau of Safety and Environmental Enforcement are found in 219 DM 1. The Secretary and the ASLM have chosen to retain certain authorities (see above 1.1 Authorities Retained at the Departmental Level). Only the authorities delegated to the Director may be further delegated to other officials within BOEM, consistent with this Handbook.

Appendix 1-1 of this chapter lists authorized activities that require the approval of the BOEM Director.

1.3 Re-delegations

The BOEM Deputy Director can exercise all of the powers and authority of the BOEM Director. These authorities may be further delegated unless re-delegation is specifically prohibited or limited. (See BOEM Manual (BOEMM) 218.2 for procedures to request delegation of authorities and revisions of the BOEMM, including this Handbook.)

¹ The Department's Office of Environmental Policy and Compliance (OEPC) Environmental Statement Memorandum (ESM) No. ESM-13-2 *Approving and Filing Environmental Impact Statements* defines a delegated EIS as "an EIS for which the decision authority on the proposed action is delegated to a single Assistant Secretary or a subordinate officer. " The ESM-13-2 defines a non-delegated EIS as" an EIS for which anyone of the following applies:

[•] the decision authority on the proposed action requires the approval of more than one Assistant Secretary (or bureaus under more than one Assistant Secretary),

[•] the decision authority is reserved or elevated to the Secretary (or Office of the Secretary) by expressed interest of the Secretary, Deputy Secretary, the Chief of Staff, the Solicitor or the Assistant Secretary for Policy, Management and Budget, or

it is so designated at the discretion of the Secretary, Deputy Secretary, or the Assistant Secretary for Policy, Management and Budget."
