



Atlantic Shores Offshore Wind South Project

What to Expect at the In-Person Open House Public Meetings

The public will be welcome to attend from 5:00 PM until 9:00 PM. No pre-registration is required.

The meetings will follow an informal, open-house format. After checking in at the registration desk, attendees can visit stations to view project information posters staffed by BOEM subject matter experts. The BOEM team can share information and answer questions in their areas of expertise.

Attendees can also view pre-recorded video presentations providing a project description and descriptions of expected impacts that will be played continuously from 5:00 PM until 9:00 PM.

The goal of the meeting is to help attendees provide written comments for the record. This can be done by using a provided comment form, providing oral comments by meeting individually with a court reporter for up to five minutes each, or at any time during the comment period by submitting comments to www.regulations.gov or by sending written comments to BOEM.
