EXECUTIVE SUMMARY

Golden State Wind LLC (GSW) has prepared this semi-annual progress report in compliance with Addendum C, Section 3.1 of Lease OCS-P 0564 (Lease). This second progress report covers December 1, 2023 through May 31, 2024.

GSW is committed to outreach and thoughtful planning with regards to community stakeholders, fisheries, Native American Tribes and Tribal Nations (Tribes), and local, state, and federal agencies. Through introductory meetings and information sessions, GSW has established relationships with, provided information to, and sought input from these external parties.

GSW has engaged in regular communication with the U.S. Bureau of Ocean Energy Management (BOEM) on regulatory requirements and Project updates. GSW has engaged with a number of other federal and state agencies to introduce and/or continue discussions on the Golden State Wind Project (Project), discuss upcoming offshore surveys, and confirm regulatory requirements. GSW's Agency Communications Plan will be updated throughout the life of the Project to ensure interested parties can access up-to-date information in an effective manner.

GSW is committed to meaningful, open communication, coordination, and collaboration with Tribes. GSW organized and held pre-survey meetings with Tribes throughout early 2024 to discuss the Project and upcoming offshore surveys. As requested by Tribes during early engagement meetings, GSW and its neighboring Central Coast Leaseholders developed a Joint Native American Tribes Communications Plan (NATCP) and distributed it to BOEM and Tribes in April 2024. The Joint NATCP is considered a living document that will continue to be updated as needed in coordination with other Leaseholders and Tribes.

GSW, through its Fisheries Liaison, has engaged local commercial and recreational fisheries and scheduled and attended relevant meetings with fishermen and fishing organizations. During this reporting period, GSW updated its Fisheries Communications Plan, which was refined based on feedback from local commercial and recreational fisheries and will continue to be updated throughout the life of the Project. GSW has also participated and engaged in relevant Pacific Fishery Management Council meetings and the 7c Fisheries Working Group Meetings.

The GSW stakeholder team has continued to meet with local community groups, universities, non-governmental organizations, trade associations, state legislators, community leaders, and other groups to create open channels of communication. Throughout the coming reporting period, GSW will continue to work with stakeholders to address continued questions and gather feedback on the Project.

1 PURPOSE AND BACKGROUND

1.1 Purpose

This Progress Report is prepared in accordance with Section 3.1 of the Lease OCS-P 0564 (Lease), which requires that Golden State Wind LLC (GSW) submit a semi-annual progress report (Progress Report) to the U.S. Bureau of Ocean Energy Management (BOEM) every six months from the date of the Lease effective date (June 1, 2023) through the approval of a Construction and Operations Plan (BOEM 2023a). This Progress Report covers the period from December 1, 2023, to May 31, 2024 (reporting period). The purpose of this Progress Report is to document GSW's overall progress and engagement activities undertaken with Native American Tribes and Tribal Nations (Tribes), fisheries, agencies, and stakeholders over the prior six-month period. This report was prepared to align with BOEM's Draft Guidelines and Instructions for Progress Report Required by BOEM New York Bight Leases and Carolina Long Bay Leases, which BOEM directed GSW to use in preparation of this report (BOEM 2023b). A list of these parties that may be potentially affected by the Golden State Wind Project (Project) activities are provided in Appendix A: Tribes and Other Parties Relevant to the Project. Relevant contact information is provided in Appendix B: Lessee and Liaison Contact Information, and GSW's Communications Plans can be found in Appendix C: Communications Plans. Each Progress Report will be updated with GSW's progress and engagement activities completed during the prior reporting period and plans for continued engagement.

1.2 Lease Information and Description

GSW is a 50/50 partnership between Ocean Winds (OW) and the Canada Pension Plan Investment Board, managed by OW. GSW obtained rights to Lease Area OCS-P 0564 (Lease Area) in BOEM's December 2022 Pacific Wind Lease Sale. The Lease Area is located on the Pacific Coast Outer Continental Shelf and is the central of three lease areas in the Morro Bay Wind Energy Area (Figure 1). The Lease Area is approximately 80,418 acres (325 square kilometers), 22 miles (19 nautical miles; 35 kilometers) offshore of California at the closest point, and 53 miles (46 nautical miles; 85 kilometers) offshore of Morro Bay, California. Water depths within the Lease Area range from approximately 3,120 feet (951 meters) to 4,540 feet (1,384 meters). The Morro Bay Wind Energy Area was designated by BOEM following a review of existing and targeted environmental studies as well as significant stakeholder engagement and input. A copy of Lease OCS-P 0564 is available on BOEM's website.¹

Once constructed, the Project will consist of wind turbine generators installed on floating platforms, mooring, and anchoring systems connecting them to the seabed, inter-array cables, floating offshore substation(s), offshore export cables, cable landfall(s), onshore export cables, onshore substation(s), and onshore interconnection cable(s) to the point(s) of interconnection to the onshore electric grid (Figure 2). If approved by federal, state, and local agencies, activities would include construction, operation, maintenance, and eventual decommissioning of the Project.

To support engineering design and permitting, site assessment activities to be conducted within the Lease Area include site characterization and survey activities involving vessel-based surveys and deployment of metocean buoys. Site assessment activities outside of the Lease Area include survey activities along proposed offshore export cable routes and onshore facilities locations.

2 TRIBAL ENGAGEMENT

GSW believes that early and active engagement with Native American Tribes and Tribal Nations (Tribes) can benefit the Project as well as Tribal communities. GSW recognizes and respects the special government-to-government relationship between the U.S. government and federally recognized Tribes as set forth in the Constitution of the United States, treaties, statutes, Executive Orders, and court decisions, as well as the experience and insight of all local California Tribes. GSW acknowledges that BOEM remains responsible for all government-to-government consultations and will continue to engage with Tribes in its capacity as the lead federal agency.

The Tribes listed in Appendix A have been identified by the California Native American Heritage Commission (NAHC) and BOEM as having cultural and/or historical ties to the Lease Area or having concerns with impacts to migratory marine species. A Tribal contact list for the Project was created with support from NAHC and BOEM; however, GSW invites other interested Tribes and parties to contact GSW directly.

2.1 Overall Engagement Progress

GSW's Tribal Liaison (ASM Affiliates) has continued to coordinate Tribal engagement and assist in establishing and maintaining positive, productive, and collaborative engagements with Tribes. SEARCH, Inc. has also continued to support Qualified Marine Archaeologist (QMA) responsibilities during pre-survey planning and development of the Joint Native American Tribes Communications Plan (NATCP).

GSW and ASM Affiliates organized and held pre-survey meetings with Tribes throughout February, March, and April of 2024 to discuss the Project and upcoming offshore surveys. Follow-up actions and outcomes are listed below in Table 1. Table 1 also includes other outreach and engagement that occurred with Tribes during the reporting period.

As requested by Tribes during early engagement meetings, GSW and its two neighboring Central Coast Leaseholders developed a Joint NATCP. The Joint NATCP was first revised to incorporate Tribal feedback and provided to BOEM on January 26, 2024, resubmitted on March 14, 2024, based on BOEM feedback, and finalized on April 8, 2024, based on additional BOEM feedback. The Joint NATCP was then distributed to Tribes on April 19, 2024. GSW coordinates with the other Central Coast Leaseholders on joint Tribal engagement and communications and holds regular coordination calls with the five California leaseholders to share best practices, discuss common topics, and to continue to improve our work with Tribes throughout the state.

2.3 Tribal Feedback on Transmission Planning

GSW is in the process of transmission planning, including identification of onshore and offshore routing constraints and development of draft transmission corridors. As part of this process, GSW will be engaging with Tribes and other parties to solicit information on routing constraints and feedback on draft corridors and routes. GSW is committed to early engagement to solicit and implement meaningful feedback on this process. To promote continuing dialogue on transmission planning, GSW will host future meetings, as described in Table 3, with interested Tribes to discuss potential transmission cable routes.

2.4 Anticipated or Scheduled Tribal Engagement Activities

A Joint NATCP was provided to Tribes and BOEM in April 2024. The Joint NATCP is considered a living document that will continue to be updated as needed in coordination with other leaseholders and Tribes. GSW will be engaging with Tribes regarding transmission planning, survey plans, and ongoing general Project updates, as detailed in Table 3.

3 ENGAGEMENT WITH POTENTIAL AFFECTED PARTIES

3.1 Overall Engagement Progress

GSW has engaged with agencies, fisheries, and other stakeholders throughout the reporting period, as described below and listed in Table 4.

3.1.1 Agencies

GSW has held or participated in numerous agency meetings and engagement activities during the reporting period, including regularly scheduled engagements, meetings to introduce the Project and team, and discussions of proposed legislation, state policy, regulations, specific permits, surveys, or studies. GSW endeavored to hold joint meetings with other leaseholders wherever possible except in cases where Project-specific information was discussed. These agency engagements included the following:

- Project introductions;
- Regularly scheduled bi-weekly and monthly coordination meetings;
- Regularly scheduled leaseholder coordination meetings;
- Survey permits, plans, protocols, and activities discussions; and
- Initial impact assessment approach or protocol discussions.

As required by Lease stipulation 3.1.3, GSW developed an Agency Communications Plan (ACP) describing the strategies for communicating with federal, state, and local agencies with authority related to the Project area and specific methods for engaging with and disseminating information related to these agencies. During this reporting period, the September 29, 2023 version of the ACP was revised based on BOEM comments and resubmitted December 1, 2023. The ACP is posted publicly on GSW's website, listed in Appendix C.

In accordance with the ACP, GSW held or attended multi-agency and/or coordinated leaseholder meetings whenever possible in order to reduce consultation burden and ensure coordinated feedback from agencies. GSW is committed to working collaboratively with other lessees to develop coordinated engagement activities. To help accomplish this coordination, the five California leaseholders worked with American Clean Power Association and developed the California Council of Offshore Wind Leaseholders. This council, with support from American Clean Power-California (ACP-CA) is dedicated to fostering the emerging California floating offshore wind market and advancing the state's first projects. Together with the other leaseholders, GSW participates in regularly scheduled monthly leaseholder meetings with the California Energy Commission (CEC) staff, CEC Chair and Governor's Office Senior Advisor for Offshore Wind. The leaseholders held joint meetings with the members of the California Legislature, Governor's Office, and state agencies during the reporting period on a variety of topics that have potential to impact offshore wind (OSW) development in California. The Central Coast Leaseholders have coordinated on meetings in San Luis Obispo and the City of Morro Bay with state, county, and local agencies, elected officials, and local stakeholders. GSW coordinates with the other leaseholders and ACP-CA and meets regularly with state agencies on legislative, regulatory, and other issues impacting OSW development. In addition, GSW coordinated with the other leaseholders to hold joint meetings with federal and state agencies to discuss issues related to the development of the communications plans and engagement with Tribes and fisheries. GSW has also coordinated with other leaseholders for meetings with the National Oceanic and Atmospheric Administration's (NOAA's) Office of National Marine Sanctuaries regarding the proposed Chumash Heritage National Marine Sanctuary.

3.1.2 Fisheries

GSW recognizes that fishing is an integral part of the cultural, historic, and economic fabric of coastal California. GSW believes that responsible development of offshore wind is contingent on early, transparent, and continuous collaboration with the fishing industry and that the success of the proposed Project depends on our ability to coexist alongside other ocean users. During the reporting period, GSW hosted a joint virtual meeting with a neighboring leaseholder and invited all fishery stakeholders to provide an overview of the Fisheries Communications Plan (FCP) and receive feedback to improve components of the FCP. As required by Lease stipulation 6.2, GSW developed a FCP describing the strategies for communicating with commercial and recreational fishing communities. During this reporting period, the November 3, 2023 version of the FCP was revised and resubmitted December 22, 2023 based on BOEM comments and then again on March 19, 2024 based on stakeholder comments. The FCP is posted publicly on GSW's website, listed in Appendix C.



GSW also spoke with individual commercial and recreational fishermen with fishing interests in or near the Project area, as well as representatives from numerous fishing organizations along the West Coast, including the Morro Bay Commercial Fishermen's Organization (MBCFO), Port San Luis Commercial Fishermen Association (PSLCFA), Pacific Coast Fishermen Federation Association, California Fishermen Resiliency Association (CFRA), Commercial Fishermen of Santa Barbara, the San Diego Fisheries Working Group, and the Coastal California Conservation Association. Other stakeholders including the Pacific Fishery Management Council (PFMC), California Department of Fish and Wildlife (CDFW), California Coastal Commission (CCC) and the National Oceanic and Atmospheric Administration's National Marine Fisheries Service (NOAA Fisheries) were also contacted. The California Offshore Wind Energy Fisheries Working Group was established in Senate Bill 286 (Chapter 386, McGuire, Statutes 2023) approved by the California Legislature, and signed by the Governor in October 2023. SB 286 Condition 7c Fisheries Working Group met for the first time December 6, 2023, and has since met for three formal meetings. GSW has participated and contributed to multiple subgroups, which are focused on specific deliverables the full group has been tasked with. The FCP will continue to be updated throughout the Project lifecycle based on engagement with commercial and recreational fisheries and participation in the 7c Fisheries Working Group and the "statewide strategy" that will be developed.

3.1.3 Stakeholders

GSW has continued engagement with a wide range of additional stakeholders, including environmental non-governmental organizations (eNGOs), universities, labor organizations, local businesses, and community members. This engagement has included Project introductory meetings, attendance of and participation in local events, and community outreach. Stakeholder meetings have progressed during this reporting period as GSW seeks input on the Project and partnerships that will facilitate responsible Project development. GSW will continue to work with the Central Coast Leaseholders on region-specific stakeholder engagement and meetings, as appropriate, and will also work through the California Council of Offshore Wind Leaseholders to coordinate meetings and outreach with stakeholders.

5 SURVEY PLAN ACTIVITIES

GSW prepared the High Resolution Geophysical & Geotechnical Survey Plan, in accordance with GSW's Lease, for proposed preliminary high resolution geophysical (HRG) investigations, bat acoustic monitoring, and limited geotechnical survey activities planned to occur in 2024 and 2025. The High Resolution Geophysical & Geotechnical Survey Plan was initially submitted to BOEM on December 7, 2023. Subsequent revisions of the High Resolution Geophysical & Geotechnical Survey Plan were submitted to BOEM, CCC, and CSLC on February 16, April 5, and May 8 of 2024. The Survey Plan adequately addressed all BOEM comments as of May 23, 2024.

GSW is planning on completing the high resolution geophysical and geotechnical surveys over a 2-year period from 2024-2025. The 2024 survey work is anticipated to be focused on the Lease Area; however, some investigations of potential export cable routes may also be conducted in federal waters, within the proposed action area analyzed in BOEM's Biological



Assessment (BOEM 2022). The HRG investigation will be completed between June 15 and December 31, 2024. The 2025 portion of the work is intended to include investigation of the export cable survey area with both AUV methodology and vessel towed/hull mounted sensors, and medium penetration seismic investigation of both the Lease Area and Coastal Survey Plan Area. An anticipated start date for the 2025 geophysical surveys has not yet been identified. Additional surveys planned for 2025 will be covered under separate survey plans.

Additionally, GSW plans to deploy bat acoustic detectors on metocean buoys in the Lease Area. While the buoys themselves will be permitted under USACE Nationwide Permit 5, pursuant to the modernization rule effective July 15, 2024, the bat acoustic detectors will be the subject of an additional survey plan submitted to BOEM.

Section 2.1 of the Survey Plan provides additional detail on the indicative survey schedule.
