### **Additional Instructions:**

- **“Primary Company Contact”** and **“Alternate Company Contact”** should be: 1) Someone *knowledgeable about the data sets* identified as used in evaluating the block(s); 2) In a position to provide *additional information* about the data upon MMS request; 3) Able to expedite the delivery of the information/data; and 4) Be available up to 30 days after the sale date.
  - **“Company Official”** means an official in accordance with signatory authorization on file in MMS Gulf of Mexico Region Adjudication Unit.
  - **“Company Address”** means the official mailing street address, city, state, and zip code of the “Company Official” above or the address where the MMS data requisition should be mailed to.
  - **“Area”** means the OCS Area of the block bid upon in the sale.
  - **“Block”** means the OCS block bid upon in the sale.
  - **“Data Type”** means whether the data is 2-D or 3-D, pre-stack or post-stack, time or depth, amplitude with offset (AVO), inversion or other enhanced processing, CSEM, gravity, etc.
  - **“Dataset Size”** means the number of line miles of 2D or the number of blocks of 3D data that comprise the data set identified.
  - **“Processing Company”** means the party who enhanced the data set identified under Data Type. *If the processing (enhancement) was done internally, please answer “In-House”. If the processing (enhancement) was not done in-house, please name the company that did the processing.*
  - **“Migration Algorithm Used”** means the type of migration (i.e. Kirchhoff, beam, wave equation, reverse time migration, etc) that has been used to enhance the data.
  - **“Processing”** means the processing sequence/velocity model used to reprocess the original data. *Please answer either “speculative” (spec) or “proprietary” (prop).*
  - **“Date Processing Completed”** means the month and year that the enhancement processing was completed.
  - **“Owner of Original Data”** means that you should indicate if the original data is proprietary to your company or if it is a multi-client survey purchased from the company who originally acquired and processed the data.. *Please answer proprietary if the data is owned by your company. If the data is not owned by your company, please answer with the name of the data owner (who acquired the original survey). This item may not be applicable if the data identified is not reprocessed.*
  - **“Original Industry Survey Name”** means that you should indicate the name of original survey. *This item may not be applicable if the data identified is not reprocessed (enhanced).*
  - **“Permit Number”** means the original permit number given by MMS when the original survey was first acquired. *This number can be obtained from the data owner.*
